5 Guam since 2010; and

1 **WHEREAS**, in 1973, Director General Wang earned his Bachelor of Arts degree,
2 Department of Diplomacy, National Cheng-Chi University; and in 1982, he earned a
3 Master of Arts degree, Department of Political Science, University of Detroit in the
4 United States; and

5 **WHEREAS**, Director General Wang has served in many important positions in
6 government agencies and prestigious organizations, such as: Officer, Department of
7 Protocol, Ministry of Foreign Affairs (1984 to 1985); Third and Second Secretary,
8 TECO in Boston, U.S.A (1985 to 1991); Section Chief, Department of Protocol,
9 Ministry of Foreign Affairs (1991 to 1994); First Secretary, Taipei Representative Office
10 in the United Kingdom (1994 to 1997); Acting Director, Taipei Representative Office
11 in the United Kingdom (1995 to 1997); Director, Taipei Representative Office in the
12 United Kingdom Edinburgh Office (1997 to 1998); Senior Specialist, Secretariat,
13 Ministry of Foreign Affairs (1998 to 2002); Deputy Director General, TECO in Chicago,
14 U.S.A (2002 to 2008); and Director General, Taipei Economic and Cultural Office in
15 Guam (2010 to 2014); and

16 **WHEREAS**, Director General Wang, along with his wife, son and daughter,
17 have made Guam their home for the last four (4) years; and he has served admirably,
18 both the people of the Republic of China (Taiwan), and the people of Guam; and

19 **WHEREAS**, Director General Wang has been extremely supportive of the
20 Chinese community of Guam, to include, the United Chinese Association of Guam;
21 the Chinese Chamber of Commerce of Guam; the Chinese Ladies Association of
22 Guam; and the Chinese School of Guam; and

9 has had a long history on Guam; and that increases the diversity of our local culture,
