1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***
2 ***MINA'TRENTAI DOS NA LIHESLATURAN GUÅHAN:***
3 **WHEREAS, Danny “*Maga’låhen Pågat*” Jackson was born on April 27, 1951**
4 **in *Aspengao, Barrigada*; and**

1 **WHEREAS**, *Pågat* is the son of Antonio Meno Jackson of *Inalåhan*, and
2 Josefina Leon Guerrero Lujan of *Dedidu*; and is the fourth child of sixteen (16)
3 children; and

4 **WHEREAS**, *Pågat* is married to Josephine Castro Jackson; and they have three
5 (3) sons: Kevin, Oscar, and Steve Jackson; and six (6) grandchildren: Gavin, Amber,
6 Alliyah, Teanna, Cason, and Magåhet; and

7 **WHEREAS**, in 1974, *Pågat* moved to live in upper *Pågat, Mangilao*; and as a
8 member of *I Nasion Chamorro*, *Pågat* has taken up the cause of indigenous fishing
9 rights; he has voiced opposition to the military build-up; and he is a staunch opponent
10 of the use of *I Sengsong Pågat* as a firing range; and

11 **WHEREAS**, *Pågat* has earned the respect and the title of “*I Maga’låhen*
12 *Pågat*” from the membership of *I Nasion Chamorro* for his advocacy of the
13 *Chamorro* culture, customs and language; and

14 **WHEREAS**, *Pågat* has been committed to caring for the preservation of *I*
15 *Sengsong Pågat*, the historical *songsong* (village), of which he has dedicated many
16 years of his life to ensuring that the village is maintained for the people of Guam and
17 tourists to enjoy its natural and pristine beauty; and

18 **WHEREAS**, the historical village is lined with a bull cart trail that was used by
19 the original villagers to commute and to move daily sustenance supplies for their
20 families; and the village is adorned with artifacts that are hundreds of years old, that
21 provide great in-depth knowledge into the lives of the *Chamorro* people who lived
22 there and set the path for our generation, and generations to come; and

23 **WHEREAS**, *Pågat* leads a sustainable life as a fisherman and farmer, showing
24 great respect toward the balance of man and land, while providing an adequate
25 livelihood for his family; and

26 **WHEREAS**, *Pågat* has acted as a guardian of *Chamorro* lands, and he was part
27 of the protest during the “camp out” at *Adelup* that forced the Governor to implement
28 the *Chamorro* Land Trust Act; and

1 **WHEREAS**, Danny *Pågat* Jackson continues to be a voice against many of the
2 injustices placed on the *Chamorro* people; and he has dedicated his life to the
3 promotion, preservation and perpetuation of the *Chamorro* language, culture, and
4 traditions, and the identity of all that is Guam, which will preserve the legacy of Guam
5 for all future generations to come; now therefore, be it


6 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Dos Na*
7 *Lihselaturan Guåhan* does hereby, on behalf of *I Lihselaturan Guåhan* and the people
8 of Guam, recognize Mr. Danny “*Pågat*” H. Jackson as “*I Maga'låhen Pågat Para I*
9 *Nasion Chamorro*”; and does further extend *Un Dångkolo Na Si Yu'os Ma'åse'* to
10 him for his service as a caretaker of *I Sengsong Pågat* (*Pågat* village), in order to
11 maintain the spirit of *Pågat* for the people of Guam and future generations to come;
12 and be it further

13 **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules
14 certify, and the Legislative Secretary attest to, the adoption hereof, and that copies of
15 the same be thereafter transmitted to Mr. Danny “*Maga'låhen Pågat*” H. Jackson; and
16 to the Honorable Edward J.B. Calvo, *I Maga'låhen Guåhan*.
