- WHEREAS, Mr. Mathew Sung, who was a loving father, a dedicated husband,

- 5 leader, passed away on August 8, 2014, at the age of ninety-one (91), leaving behind
- 6 his loving wife of fifty-six (56) years, Nancy L.C. Sung; his son, York; his daughter,

WHEREAS, Mr. Mathew Sung was born in 1923, and is from a prominent family of Hunan Province in China. He entered formal schooling at the age of six (6), and he excelled throughout his school years. Upon his graduation from college, Mr. Sung taught classes for a few months; and he then felt the hardship of the country, and took upon himself the responsibility to serve the country; and he was successfully accepted into the Central Military Academy. After three (3) years of hard work and training, Mathew graduated among the top five (5) out of one thousand five hundred (1,500) graduates, and he was personally awarded with a saber by then Principal, Generalissimo Chiang Kai Shek. Mr. Sung then began training future officers from August 1945 when Japan announced their unconditional surrender until 1949 when the Kuomintang Forces retreated to the island of Taiwan. Despite being an accomplished educator, Mathew still continued to study and learn the English language on his own; and he was successfully accepted into the Foreign Institute of the Defense Academy, and was eventually sent to a military engineering university in the United States. This changed the direction of his life and he prepared himself for his future employment opportunities. Mr. Sung had also received numerous awards and decorations while serving his country in his various positions nationally and internationally; and

WHEREAS, in 1971, Mr. Sung officially retired from the Army with the rank of Colonel; and he eventually found his way to Guam to assume the management of RSEA Construction Company, which was comprised mostly of retired military personnel from Taiwan. The company was awarded with various projects for the U.S. military; and at one time, the company had one of the largest workers' camp on

- 1 Guam. Despite his busy work schedule, Mathew found time to serve the needs of the
- 2 local Chinese community, and he built good relationships with the local community.
- 3 To better improve the communication with one another, Mr. Sung, together with other
- 4 prominent Chinese leaders of that time, founded the United Chinese Association of
- 5 Guam in 1972, and he was elected to serve as its President in 1974; and
- WHEREAS, some of the most memorable accomplishments of Mr. Sung was
- 7 when he organized the Guam delegation to attend the inauguration of President
- 8 Chiang Kai Shek in May 1972. He also arranged the official visit of former Guam
- 9 Governor Carlos Camacho to Taiwan. In 1974, Mr. Sung assisted the Government of
- 10 Guam to invite then Taipei City Mayor Chang to visit Guam; and he helped to form a
- sister city relationship between Guam and Taipei City. He built the Guam Chinese
- 12 Park through the cooperation of RSEA Construction Company and the United Chinese
- 13 Association of Guam; and
- WHEREAS, Mr. Sung was instrumental in building the Guam Chinese School
- 15 Building in Upper Tumon; he established the Fung Ling Educational Foundation to
- help underprivileged youths to pursue higher education; and he set up the Sung Tuan
- 17 Sheng Scholarship in honor of his father; and
- 18 WHEREAS, some of the positions Mr. Sung had held in his many acts of
- 19 community service include: being the past President of the United Chinese
- 20 Association of Guam; past Chairman of the Guam Chinese School Foundation; past
- 21 Secretary General of the Guam Chinese School Board of Trustees; and past Publisher
- of the Guam Chinese Overseas News; now therefore, be it
