3           **WHEREAS,** Reverend Father Patrick ('*Påle' Pat*') Kenny Quitonguico Garcia  
4 was born on March 3, 1964; and he is the son of the late James Estolas and Florentina  
5 G. Estolas; and

1           **WHEREAS,** *Pale'* Pat grew up in *Tamuning*, Guam, and while in his youth he  
2 had devoted many years as an altar server at the parish of St. Anthony and St. Victor  
3 in *Tamuning*; and

4           **WHEREAS,** *Pale'* Pat attended *Agaña* Heights Elementary School, *Dededo*  
5 Middles School, Father Dueñas Memorial School (FDMS), and John F. Kennedy  
6 High School, where he graduated in 1980; and

7           **WHEREAS,** *Pale'* Pat entered the FDMS Minor Seminary in 1977; and after  
8 graduation, he attended the University of Guam, from 1980 to 1981; and

9           **WHEREAS,** in 1981, *Pale'* Pat continued his studies at St. Joseph's College,  
10 and he graduated with a Bachelor of Arts degree in Humanities in 1985; and

11           **WHEREAS,** *Pale'* Pat then attended St. Patrick's Seminary and University  
12 from 1985 to 1989, where he earned a Masters in Divinity; and

13           **WHEREAS,** *Pale'* Pat was ordained to the Transitional Diaconate on April 22,  
14 1989 at St. Mary's Cathedral in San Francisco, California; and

15           **WHEREAS,** on July 16, 1989, *Pale'* Pat was assigned as an Administrator of  
16 the San Isidro Catholic Church in *Malojloj*; and

17           **WHEREAS,** on September 30, 1989, *Pale'* Pat was ordained as a Priest of the  
18 Archdiocese of *Agaña*, at the *Dulce Nombre de Maria* Cathedral-Basilica; and

19           **WHEREAS,** *Pale'* Pat's first pastoral assignment was to the parish of San  
20 Isidro in *Malojloj*, where he served as Pastor from July 1989 to September 1996; and

21           **WHEREAS,** *Pale'* Pat was also assigned to various parishes, to include,  
22 serving at *Nuestra Senora de Las Aguas* in *Mongmong* as Pastor, from September  
23 1996 to February 2003; at Santa Barbara Catholic Church in *Dededo* as Parochial  
24 Vicar, from July 2005 to 2009; and at Our Lady of Lourdes Catholic Church in *Yigo*  
25 as Parochial Vicar, where he has served from 2010 to the present; and

1           **WHEREAS**, *Pale'* Pat had also served our brothers and sisters of the  
2 Commonwealth of the Northern Mariana Islands while he was assigned to the St. Jude  
3 Thaddeus Parish in Koblerville, Saipan; and

4           **WHEREAS**, *Pale'* Pat had served as the Director of Worship for the  
5 Archdiocese of *Agaña* for many years, assisting the Archdiocese with planning  
6 Eucharistic celebrations, and other Archdiocesan events, for the island community;  
7 and

8           **WHEREAS**, *Pale'* Pat has extended his love for God in teaching at San  
9 Vicente Catholic School in *Barrigada*, Notre Dame High School in *Talofof*, Father  
10 Dueñas Memorial School in *Mangilao*, and Mount Carmel Catholic School in Saipan;  
11 and


12           **WHEREAS**, *Pale'* Pat enjoys reading, listening to religious music, and most
