3           **WHEREAS,** Ms. Dee Cruz is from the beautiful village of *Agaña* Heights. She  
4 is the proud mother of Chanel Cruz Jarret; her parents are Mr. Noel Peter Torres Cruz  
5 and Mrs. Teresita Guzman Santos; and she has three (3) siblings; and

1           **WHEREAS**, Ms. Cruz is an indigenous *Chamorro* woman who continues to  
2 epitomize Guam’s matriarchal culture through her measureless care and invaluable  
3 service to others in our community. Dee has proudly served our island and our country  
4 as a member of the U.S. Marine Corps from 1991 to 1997; and for the past thirteen  
5 (13) years, Ms. Cruz has served the people of Guam in the field of emergency  
6 management, and has been employed as an E-911 Emergency Medical Dispatcher,  
7 and at the Transportation Security Administration; and

8           **WHEREAS**, Dee Cruz is the State Training & Exercise Program Manager and  
9 Critical Infrastructure Coordinator for the Guam Homeland Security/Office of Civil  
10 Defense, and has been responsible for planning, developing, coordinating,  
11 implementing and evaluating the emergency management, emergency response  
12 training and exercise activities for our island. She has been instrumental in mobilizing  
13 hundreds of individuals in the public and private sector during the onset of storms and  
14 natural disasters by actively engaging them to participate in emergency response  
15 efforts for any natural or man-made incidents on Guam’s horizon. She continues to  
16 ensure that the Agency carries out its mission for the people of Guam by keeping our  
17 island community current and compliant with the mandates of all the U.S. Homeland  
18 Security agencies across the nation and in the territories; and

19           **WHEREAS**, Ms. Cruz has helped many families on Guam during their times  
20 of need through her influence and volunteerism with numerous medical fundraisers;  
21 she had assisted with raising funds for a family who could not bury their loved one;  
22 she has held donation drives for disaster victims; and recently, she helped several  
23 families who were devastated by Tropical Storm Halong in August 2014; and

24           **WHEREAS**, Dee’s love for our island and its people is truly commendable,  
25 and it has left an everlasting impression of gratitude from the lives she has touched.


10 **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules
