Relative to recognizing and congratulating Mrs. Evangeline Apilado Manibusan, BSN, RN, NP, on the occasion of her retirement from the Guam Department of Public Health and Social Services after twenty-four (24) years of dedicated and superior service; and to further extending *Un Dångkolo Na Si Yu'os Ma'åse'* to her for her service to our island's most vulnerable children, youth and *manåmko'*, and all the people of Guam.

BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I MINA'TRENTAI DOS NA LIHESLATURAN GUÅHAN*:

WHEREAS, Evangeline A. Manibusan is the daughter of the late †Amadio B. and †Trinidad D. Apilado; and is the second child, with an older brother, Artemio Apilado; and

WHEREAS, growing up, Evangeline and her family experienced a military life as part of the United States Air Force, and she had traveled and resided in many states; and

WHEREAS, after many years living abroad, Evangeline moved to Guam; and during her high school years, she attended John F. Kennedy High School, where she graduated in 1973; and

WHEREAS, Evangeline continued in her higher education and attended the University of Guam School of Nursing, where she graduated with an Associates Degree in Nursing in 1977; and

WHEREAS, from 1977 to 1978, Evangeline was employed at the Guam Memorial Hospital Authority, serving in the Surgical Ward; and

WHEREAS, Evangeline married her high school sweetheart, Mr. Joseph Camacho Manibusan, on April 15, 1978; and

WHEREAS, Evangeline then began her career at the Guam Department of Public Health and Social Services in 1979 prior to leaving the island in 1983 to pursue higher studies; and

WHEREAS, while living in California, Evangeline obtained her Women's Health Nurse Practitioner Certificate from the Harbor General Medical Center at UCLA, in Torrance, California, in 1981; and

WHEREAS, Evangeline and her family returned to Guam in 1995, and she continued in her practice in health care at the Central Regional Health Center Clinic in *Mangilao*; and

WHEREAS, Evangeline is an example of an exemplary employee, possessing the traits of a hard-working, dedicated and compassionate professional that have

caused her to be recognized throughout the nursing profession as a true role model; and

WHEREAS, Evangeline is a Community Health Nurse Supervisor II with the Department of Public Health and Social Services' Bureau of Family Health and Nursing Services (BFHNS), and she has served the people of Guam for twenty-four (24) years; and

WHEREAS, Evangeline supervises sixteen (16) nursing staff in the Maternal and Child Health (MCH) Clinic, the Immunization Clinic, the Family Planning Clinic, the New Born Screening Clinic, the Pregnancy Testing Clinic, and the Communicable Diseases Clinic; and

WHEREAS, although not required, Evangeline makes it a point to see up to thirty (30) patients in the Medical Clinic, devoting 16 to 20 hours weekly; and

WHEREAS, when Evangeline is not treating patients at the clinic, she is busy working on reports, updating and revising policies and protocols, attending or chairing committees and meetings, participating in health fairs and outreach programs, and teaching or conducting training; and

WHEREAS, Evangeline also assumes the Bureau of Family Health and Nursing Services Administrator duties when the Administrator is off-island; and

WHEREAS, Evangeline has continued to practice as a Nurse Practitioner for the MCH and Family Planning Programs performing physical examinations, and making interpretations of findings and diagnosis. Evangeline orders the appropriate diagnostic tests and promptly reports abnormal findings that need further evaluation to the physician; and

WHEREAS, Evangeline is further responsible for planning and instituting treatment for the patients' condition and prescribing medications based on approved nurse practitioner women's health protocols; and

WHEREAS, Evangeline is also a nurse practitioner for the Honolulu Shriners Telemedicine Clinics, seeing about six (6) special needs patients monthly; and

WHEREAS, Evangeline was instrumental in the success of the Maternal and Child Health Grant, as she was responsible for reporting on the performance measures of Tobacco Youth, Smoking, Koltelchuck Index and Prenatal Teens; and with these contributions the grant was awarded; and

WHEREAS, Evangeline was committed to maintaining the highest standard of care in her assistance in the update and revision of the Family Planning and Women's Health Care Protocols, which is now used as a model protocol in other jurisdictions; and she further assisted in updating and revising protocols for the Pap Smear Follow-up Policy and Prenatal Protocol Policy, and the Reproductive Health Protocols, to include HIV/STD, UCG Pregnancy Test and Family Planning Counseling; and

WHEREAS, Evangeline was influential in the success of the "Healthy Mothers, Healthy Babies Fair," which is held annually at the Micronesia Mall, chairing the event in 2013; and

WHEREAS, Evangeline is an active Member of the Guam Nurses' Association, and serves as the Director-at-Large; and she was the recipient of the 2013 "Nurse Practitioner of the Year" Award for the Association; and

WHEREAS, Evangeline is a Tobacco Dependence Treatment Specialist and Tobacco Treatment Specialist Instructor, and she is also a preceptor for the University of Guam Nursing Student Practicum for Community Health Nursing and Leadership; and

WHEREAS, Evangeline takes an active part in many community and departmental events, including: the Breast Cancer Awareness Month Wave; the Stop Violence Against Women Campaign; the Homeless Survey Count; the Passport to Homeless Outreach; the Payless Kick the Fat 5K; the Worksite Wellness Campaign;

the Healthy Lifestyles, Healthy Generation Health Fairs; the National Children's Dental Health Month Fair; and various Bone Marrow Drives; and

WHEREAS, Evangeline has provided support for the health screenings of hundreds of students at JFK High School and Simon Sanchez High School; for inmates at the Department of Corrections during a time when PPD skin tests were needed; and at the Department of Youth Affairs when a scabies problem arose. She also contributed to the success of Senior Citizens' Month Festivities as a First Responder to the events; and

WHEREAS, Evangeline has been known to go above and beyond what is expected of her, and she does whatever she can to serve her community. With her enthusiasm, she has infected her positive energy and love for her work with the people she works with; and

WHEREAS, Evangeline's retirement will include spending quality time with her family, to include her children and their spouses; and her grandchildren: Jeanette Manibusan & Gener Lumbre; Theresa A. Manibusan; Lorena A. Manibusan & Jayson Guadalupe and their children, Margoux and Jayvin Manibusan Guadalupe; and

WHEREAS, Evangeline's retirement, though bittersweet, will be advantageous for her family as she will now be able to enjoy her grandchildren, and spend time doing the many things she loves to do; now therefore, be it
