3 **WHEREAS**, the FSM, which attained its independence on November 3, 1983,  
4 is comprised of the island states of Chuuk, Yap, Kosrae, and Pohnpei; and

5 **WHEREAS**, Guam is a unique island inclusive of various cultures and  
6 currently home to thousands of individuals who are of FSM descent; and

7 **WHEREAS**, the people of Guam continue to have a strong relationship with  
8 the FSM community of Guam, one that has been built by years of friendship, kinship,  
9 and a shared sentiment of wanting all Guamanians to prosper and succeed; and

10 **WHEREAS**, the contributions by members of Guam's FSM community have  
11 proven to be invaluable and beneficial to the overall success of Guam and its people;

13 **WHEREAS**, with the support from many community partners, including the  
14 FSM Consulate Office, the Mayors Council of Guam, the Guam Behavioral Health  
15 and Wellness Center's Prevention and Early Advisory Committee Empowerment  
16 Partnerships for Success Project, members of Guam's business community, and  
17 regional leaders from both the FSM national and state governments, the FSM  
18 Community Care organization, along with members of the FSM community on Guam,  
19 will celebrate "FSM National Day" on November 1, 2014, with the theme: "The Ideal  
20 Micronesian Family"; and


21 **WHEREAS**, in addition to the showcasing of cultural cuisine, dance, and song,

5 toward strengthening relationships with Guam’s local residents; and be it further


6 **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules


