9 at the UCLA Hospital and Clinic in Los Angeles, California; and


1 **WHEREAS**, Dr. Palafox also attained a Master of Public Health Degree

7 Guam; now therefore, be it


8 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Dos Na*


