1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***
2 ***MINA'TRENTAI DOS NA LIHESLATURAN GUÅHAN:***

3 **WHEREAS**, the late Honorable Jesus Q. Torres, affectionately known as
4 “Jess,” was born on August 14, 1942; and is the son of the late Jose Pangelinan and
5 Felicita Quinene Torres. He was called to his eternal rest on November 10, 2014; and

6 **WHEREAS**, the late Honorable Jesus Q. Torres is a graduate of George
7 Washington High School; and he pursued his higher education at the University of
8 Nebraska, where he earned a Bachelor of Arts Degree in Political Science; and

1 **WHEREAS**, having recognized early in his career that the best work in
2 life is service to the people, the late Honorable Jesus Q. Torres made public
3 service his life's work; and he had well and faithfully served the people of
4 Guam and our nation for decades; and

5 **WHEREAS**, the late Honorable Jesus Q. Torres is a Veteran of our
6 nation's Armed Forces, having served in the U.S. Army from February of 1967
7 to February of 1969; at which time he achieved the rank of E-5; and

8 **WHEREAS**, the late Honorable Jesus Q. Torres returned to Guam
9 following his Honorable Discharge from the Army, and he accepted a position
10 to serve as a Staff Assistant of the late Honorable Carlos G. Camacho, the first
11 elected Governor of Guam; and

12 **WHEREAS**, since that time, the late Honorable Jesus Q. Torres has
13 served as the Deputy Director of the Guam Department of Land Management;
14 he was the Administrative Director of the Fifteenth (15th) Guam Legislature; he
15 was elected to serve as a Senator in the Sixteenth (16th) Guam Legislature; he
16 served for twelve (12) years as the Executive Manager of the A.B. Won Pat
17 International Airport Authority, Guam; and he had served as a member of the
18 Board of Directors of the Guam Economic Development Authority and the A.B.
19 Won Pat International Airport Authority; and

20 **WHEREAS**, the late Honorable Jesus Q. Torres was an active member of
21 the Republican Party of Guam, and he had served as its Chairman, during which
22 time he was instrumental in maintaining party unity while continuing the party's
23 growth and success; and

24 **WHEREAS**, the people of Guam mourn the passing of the late Honorable
25 Jesus "Jess" Q. Torres, a son of Guam who dedicated his life to public service
26 for the good of Guam and its people; now therefore, be it

1 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Dos Na*
2 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people
3 of Guam, recognize and honor the late Honorable Jesus (Jess) Q. Torres, former
4 Senator, for his achievements, his accomplishments, and his many years of service
5 to the people of Guam; and does further extend its sincere condolences to his
6 family; and be it further

11 *Guåhan*.


