1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***
2 ***MINA'TRENTAI DOS NA LIHESLATURAN GUÅHAN*:**

3 **WHEREAS**, in 1978, the Public Market, the precursor of *I Sengsong*
4 *Chamorro*, was created as an entity of the Guam Department of Commerce through
5 Public Law 14-154; and it was used as the premiere show place to display the
6 *Chamorro* culture; and

7 **WHEREAS**, during the 1960s and 1970s, *I Sengsong Chamorro* was known as
8 the Guam Farmers Market, where farmers assembled to show and sell their produce

1 and livestock, which soon became the Guam Public Market and was also referred to as
2 *Sagan Dinaña*; and

3 **WHEREAS**, the Guam Farmer’s Market was upgraded and expanded to
4 include numerous business vendor stalls and a large central pavilion to accommodate
5 increased traffic flow through the Market, and thus changed its name to *I Sengsong*
6 *Chamorro*, and opened its doors in December 1994; and

7 **WHEREAS**, *I Sengsong Chamorro*, the Spanish colonial-style little shopping
8 “village”, is known for its Wednesday Night Market that has been offering Guam’s
9 visitors a glimpse into the island’s culture, lifestyle, and delicious cuisines by
10 featuring handicrafts, clothing, restaurants, a variety of fresh fish, produce, plants and
11 flowers sold by local farmers, entertainment by talented local cultural dance groups
12 and live local bands, and demonstrations by master crafters, as well as costumes and
13 exhibitions by Guam’s youths; and


14 **WHEREAS**, *I Sengsong Chamorro* is a venue where local entrepreneurs,
15 artists and craftsmen can participate in the economic activities of the island and help
16 to preserve the *Chamorro* culture through the marketing of local talent and
17 craftsmanship; now therefore, be it

- 2 the Honorable Edward J.B. Calvo, *I Maga'lahen Guåhan*.


