3 **WHEREAS**, Mr. Juan Rojas Indalecio, who is a Veteran of Foreign Wars, was
4 born in *Agaña*, Guam, on March 14, 1932; and is the second child of the four (4)
5 children of †Vicente I. Indalecio and †Rosario Rojas Indalecio; and

1 **WHEREAS**, Mrs. Eugenia Rivera Espinosa was born in *Agana*, Guam, on
2 April 1, 1935; and is the second child of the nine (9) children of †Juan Castro
3 Espinosa and †Beatrice Rivera Espinosa; and

4 **WHEREAS**, Mr. and Mrs. Espinosa were blessed with five (5) children: John
5 Jr., Vincent, Vivian, Agnes, and Patrick; twelve (12) wonderful grandchildren; two (2)
6 great-grandchildren; and their family pet Chihuahua, Biba; and

7 **WHEREAS**, after the end of World War II, Juan Indalecio, who was thirteen
8 (13) years old at the time and from the village of *Toto*, would walk every day to
9 *Sinajana* to see ten (10) year old Eugenia Espinosa; frequenting a neighborhood store
10 just to get a glimpse of his childhood sweetheart, sometimes even waiting for six (6)
11 to eight (8) hours to see her; and

12 **WHEREAS**, Juan and his best friends, Felix Ada and Ricardo Okada, would
13 serenade Eugenia every night, while all the neighbors watched and listened; and

14 **WHEREAS**, for her eighth (8th) grade graduation, Juan, and his brother Martin,
15 went to *Alupang* island to pick purple island flowers for her, which became his
16 favorite color for Eugenia; and

17 **WHEREAS**, on July 10, 1952, Juan joined the U.S. Navy and promised his
18 childhood sweetheart that he would return and marry her; and about a year and half
19 later, Juan learned that there was another young man who was interested in her. He
20 was so upset that he wrote to KUAM radio and asked them to read a letter on the air
21 that he had written to Eugenia, and to dedicate a song to her. His letter said, “Eugenia
22 Espinosa, I hope you are listening because no matter what happens, I still love you
23 very much...This song is for you, “Your Cheating Heart”; and

24 **WHEREAS**, Juan had courted Eugenia for over seven (7) years; and on
25 December 17, 1954, Juan and Eugenia united in the bonds of Matrimony, and have
26 continued their true love story; now therefore, be it

2 on behalf of the people of Guam, congratulate and honor Mr. and Mrs. Juan Rojas and
