3 **WHEREAS,** Kevin C. Masnayan was born on Guam on June 7, 1965; and is
4 the son of Ricardo P. and †Soledad Masnayan. He has seven (7) brothers and nine (9)
5 sisters; and

6 **WHEREAS,** Kevin C. Masnayan is married to the former Maria Polk, who is
7 the daughter of James Polk and †Roquita Camacho; and

1 **WHEREAS**, Kevin C. and Maria Polk Masnayon were married on April 11,
2 2005, and they are residents of *Agaña* Heights, Guam. They have been blessed with
3 four (4) children: Michael T.P. Sablan, age 26; Mason P.P. Sablan, age 22; Kevin Jr.,
4 age 23; and Chelsea, age 19; and are also blessed with a grandson, Trinity Resendez,
5 age 9; and

6 **WHEREAS**, Mr. Kevin C. Masnayon and his siblings grew up playing baseball
7 and softball with their father, a softball player from the Philippines, who played for the
8 Camp Roxas, Masdelco team, being a great influence; and the fact that the family's
9 residence is located right behind the *Agaña* Heights Baseball Field; and

10 **WHEREAS**, growing up, Mr. Kevin C. Masnayon decided to learn the trade of
11 umpiring with the hope of giving back to the community, having experienced softball
12 and baseball games being cancelled due to the lack of umpires and encountering
13 numerous disappointments because of the cancellations; and

14 **WHEREAS**, Mr. Masnayon's decision, desire and perseverance to learn the
15 trade of umpiring allows for all softball and baseball players, young and old, to
16 continue enjoying the sport that he has grown to love; and

17 **WHEREAS**, Mr. Kevin C. Masnayon received his General Education from the
18 Guam Community College in 2007; and then he was employed at the Pacific Star
19 Hotel for eight (8) years, working as a Security Supervisor; and has worked for the
20 past eighteen (18) years as a Community Maintenance Worker/Sports Coordinator at
21 the *Agaña* Heights Mayor's Office; and

22 **WHEREAS**, Mr. Kevin C. Masnayon has nineteen (19) years of umpiring
23 experience with the Guam Little League, and the Junior, Senior and Big Leagues, in
24 both the regular seasons and during regional tournaments. He also umpired for the
25 Budweiser Baseball League (the former Guam Major League), the Guam Masters
26 Baseball League, and occasional softball games; and

1 **WHEREAS**, major achievements accomplished by Mr. Masnayon include,
2 being an umpire at the Senior League World Series in Bangor, Maine in 2004; the
3 Little League World Series in Williamsport, Pennsylvania in 2008; and his most recent
4 selection as the Umpire Crew Chief for the 2014 Senior League World Series in
5 Bangor, Maine, which was a first for a Guam Umpire; and

6 **WHEREAS**, Mr. Masnayon also enjoys playing softball, baseball, dancing, and
7 singing while barbequing; and


8 **WHEREAS**, Mr. Kevin C. Masnayon continues to also spend much of his time

18 now therefore, be it


19 **RESOLVED**, that *I Mina'Trentai Dos Na Liheslaturan Guåhan* does hereby, on
