1 WHEREAS, Mr. Dominguez worked for the Guam Power Authority (GPA) from 1973-1975, and was responsible for the construction inspection of the 115 KV 2 3 (kilovolt) transmission line for the then-new Cabras Power Plant; and 4 WHEREAS, after leaving GPA, Mr. Dominguez served as Marketing Manager 5 for the Xerox Corporation in Guam from 1975-1986; and 6 WHEREAS, in 1986, Mr. Dominguez began working at Century 21 Commonwealth Realty as an Associate Broker, where he marketed commercial and 7 residential real estate sales, leases, and rentals. Additionally, he managed commercial 8 9 and residential properties until separating from the company in 1996; and WHEREAS, Mr. Dominguez began working at Continental Micronesia, Inc., a 10 subsidiary of Continental Airlines, in 1997.
