6 have a daughter, Adora Carmen B. Erguiza; and

7 **WHEREAS**, Mr. Erguiza is a 1975 alumnus of Father Dueñas Memorial
8 School in Tai, *Mangilao*; and he received his Bachelors degree in
9 Business/Accounting from Chaminade University in Honolulu, Hawaii; and

10 **WHEREAS**, Mr. Erguiza worked at the Bureau of Budget and Management
11 Research from December 22, 1982 to October 27, 1987. He then moved on to work at
12 the Office of Public Accountability from October 28, 1987 to December 24, 1999; and
13 then worked at the Guam Department of Education from December 27, 1999 to
14 December 31, 2014, serving in the positions of Auditor III and Program Coordinator
15 III; and

16 **WHEREAS**, in 1986, Mr. Erguiza received special training which was
17 sponsored by the Department of Interior, Office of the Inspector General; and he has
18 since received many commendation letters from the United States Department of
19 Education; and

20 **WHEREAS**, over the years, Mr. Erguiza has spent much of his time serving
21 the community through the San Dimas Catholic Church in *Malesso*, and the Saint
22 Anthony-Saint Victor Catholic Church in *Tamuning*; and

23 **WHEREAS**, after serving for thirty-four (34) years, three (3) months and
24 fifteen (15) days with the government of Guam, Mr. Erguiza will now retire on
25 December 31, 2014, after serving as a GDOE Program Coordinator III; now therefore,


