1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I MINA TRENTAI DOS NA**

3 **WHEREAS**, Speaker Judith T. Won Pat established an internship program during the
4 term of *I Mina'trentai Unu na Liheslaturan Guáhan*; and

5 **WHEREAS**, the program provides training opportunities wherein interns are able to
6 gain leadership, research, and work place skills and experiences; and

7 **WHEREAS**, the intern program was established as the Public Policy Institute (PPI) and
8 has evolved into a highly competitive, unique and rigorous program; and

9 **WHEREAS**, interns learned first-hand about the island's legislative process by
10 participating in a variety of activities from bill research and writing, organizing and
11 conducting public policy briefings, paging, and by providing executive-level staffing as well as
12 responding to constituent inquiries, drafting correspondence, and assisting with general office
13 operations; and

14 **WHEREAS**, interns are exposed to a vast network of distinguished leaders as well as to
15 an array of professional and training opportunities; and

16 **WHEREAS**, the internship program has received regular media exposure and attention
17 from institutions of higher learning, civic organizations and the public-at-large; now,
18 therefore, be it

1 **RESOLVED**, that the Committee on Rules of *I Mina'trentai Dos Na Liheslaturan Guåhan*,
2 does hereby, add a new section (l) to Section 2.0 Duties of the Speaker of Rule II, Part A of *I*
3 *Otden Areklamento* (Standing Rules), *I Mina'trentai Dos na Liheslaturan Guåhan* to include an
4 internship program within *I Liheslaturan Guåhan* under the auspices of the Speaker of *I*
5 *Liheslaturan Guåhan*.; and be it further

6 **RESOLVED**, that the Office of the Speaker shall adopt the rules, criteria and duties
7 required of members the internship program; and be it further

8 **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules certify,
9 and the Legislative Secretary attest to, the adoption hereof, and that copies of the same be
10 thereafter transmitted to all members of members of *I Liheslaturan Guåhan*.
