1 BE IT RESOLVED BY I MINA'TRENTAI DOS NA LIHESLATURAN  
2 GUÅHAN:

3 WHEREAS, I Mina'Trentai Dos Na Liheslaturan Guåhan Otden  
4 Areklamento, known as the Thirty-Second Guam Legislature Standing  
5 Rules, establishes the rules and procedures of I Mina'Trentai Dos Na  
6 Liheslaturan Guåhan; and

7 WHEREAS, the Standing Rules were duly adopted by lawmakers on  
8 January 7, 2013; and

9 WHEREAS, Part A Section 1.01 (b)(2) Removal of Officers and  
10 Attachés states: "Eight (8) votes of the Members of the Committee on Rules  
11 shall be required for the removal of the Speaker, the Vice-Speaker, the  
12 Legislative Secretary, or any Standing Committee Chairperson. Eight (8)

13 votes of the Members of the Committee on Rules shall be required for the  
14 removal of any Legislative Attaché;" and

15 **WHEREAS**, it is the will of the Guam Legislature that all members of  
16 *I Mina'Trentai Dos Na Liheslaturan Guåhan* be able to take part in such  
17 significant matters; and

18 **WHEREAS**, *I Mina'Trentai Dos Na Liheslaturan Guåhan* desires to have  
19 all members included in votes under this section of the Standing Rules to  
20 ensure the entire body is represented by majority rule; now, therefore, be it

21 **RESOLVED**, that *I Mina'Trentai Dos Na Liheslaturan Guåhan* does  
22 hereby amend Standing Rules Part A, Section 1.01 (b)(2) Removal of  
23 Officers and Attachés to now read: "Eight (8) votes of *I Mina'Trentai Dos Na*  
24 *Liheslaturan Guåhan* shall be required for the removal of the Speaker, the  
25 Vice-Speaker, the Legislative Secretary, or any Standing Committee  
26 Chairperson. Eight (8) votes of *I Mina'Trentai Dos Na Liheslaturan Guåhan*  
27 shall be required for the removal of any Legislative Attaché;" and be it

29 **RESOLVED**, that the Speaker and the Legislative Secretary attest to,  
30 the adoption hereof, and that copies of the same be thereafter transmitted  
31 to all members of *I Mina'Trentai Dos Na Liheslaturan Guåhan* and to the
