3 **WHEREAS, 2015 marks the 70th anniversary of the end of World War II,**
4 **during which the *Chamorro* people suffered terribly from the unspeakable**
5 **atrocities committed on our beautiful island of Guam in the name of war; and**

1 **WHEREAS**, this year also marks the 70th anniversary of the detonation of
2 nuclear weapons that were inflicted upon the innocent citizens of Hiroshima and
3 Nagasaki, Japan; and

4 **WHEREAS**, 2015 additionally marks the 70th anniversary of the founding
5 of the United Nations (UN), a body that SGI President Daisaku Ikeda has
6 consistently, relentlessly and substantively supported as the “Parliament of
7 Humanity” where each nation of the world is represented with an equal voice; and

8 **WHEREAS**, Dr. Ikeda has an unshakeable belief that to protect the United
9 Nations is to protect our nations, ourselves, our children and our future, and has
10 resulted in the UN conferring a Non-Governmental Organization (NGO) status on
11 the SGI for providing crucial and deeply appreciated support, and awareness-
12 raising energy, for many decades; and

13 **WHEREAS**, for almost 60 years, SGI President Daisaku Ikeda has been an
14 outstanding world leader for the global peace movement, in particular the effort to
15 abolish nuclear weapons, responding to the clarion call of his cherished mentor,
