3           **WHEREAS,** the Golf Tournament Association for the Governor's Cup, Inc.  
4 (GTAGCI) was founded by Charter Members Tetsuo Takano, Norio Nakajima, and  
5 Yoshiko Ogawa; and

1           **WHEREAS**, the Golf Tournament Association for the Governor’s Cup, Inc.  
2 was formed in 2003 as a non-profit organization to promote Guam to overseas tourism  
3 markets through various sports and events; and to assist charitable and sports  
4 organizations with their activities; and

5           **WHEREAS**, the Golf Tournament Association for the Governor’s Cup, Inc.  
6 was succeeded by the Golf Tournament Association for the Guam Governor’s Cup,  
7 Inc. in August 2014; and its current members consist of Karl Pangelinan, Chairman;  
8 Hiroyuki Miyata, President; Akihiko Tanaka, Treasurer; and Yoshiko Ogawa,  
9 Secretary; and

10           **WHEREAS**, the GTAGCI also sponsors and promotes competitive, as well as  
11 recreational, local, regional, national and international sports competitions, to include  
12 events, and trainings on Guam; and

13           **WHEREAS**, the GTAGCI works jointly with both the private and government  
14 sectors concerning the promotion of sound sports policy on Guam, and encourages the  
15 participation of the residents of Guam who are interested in advancing in sports; and

16           **WHEREAS**, in February of 2003, the first Guam Governor’s Cup Ladies  
17 Invitational Golf Tournament was held at the Leo Palace Resort and Country Club;  
18 and since then, it has always been held at the end of January; and

19           **WHEREAS**, this year’s 13<sup>th</sup> Annual Guam Governor’s Cup Ladies Invitational  
20 Golf Tournament is being led by the current President of the Association, Mr.  
21 Hiroyuki Miyata; and it is taking place from January 28 to January 31, 2015, at the  
22 Leo Palace Resort and Country Club; and

23           **WHEREAS**, professional lady golfers from Japan are participating in the Golf  
24 Tournament, with the support and sponsorship of the Guam Visitors Bureau, the Leo  
25 Palace Resort and Country Club, and Atkins Kroll, Inc.; and


1           **WHEREAS**, 2015 is the thirteenth (13<sup>th</sup>) year that the GTAGCI has sponsored
