2 ***MINA'TRENTAI TRES NA LIHESLATURAN GUÁHAN:***

3 **WHEREAS,** Cecilio Mantanona Meno, known to his family and friends as

4 "James," was born on Guam on December 29, 1953; and he is the son of †Ignacio

5 Quitugua and †Maria Mantanona Meno from the village of *Inarajan*; and

1 **WHEREAS**, Cecilio is the second child of twelve children; and his siblings are
2 Maryann, Linda, †Ignacio Jr., Geraldine, Charles Roy, Vivian, Jesse, BabyJo, †Lucy,
3 †Michael, and †John. In 1968, Cecilio and his family moved from *Merizo* to live in
4 *Malojloj*; and

5 **WHEREAS**, in June of 1972, Cecilio joined the United States Army; and he
6 was stationed at Fort Lewis, Washington, and then later served in Korea; and

7 **WHEREAS**, on February 8, 1975, Cecilio married Agnes Quidachay, also a
8 resident of *Malojloj*, and they were blessed with two children, Shawn and Colleen;
9 and two grandsons, Baron and Ythan; and

10 **WHEREAS**, Cecilio's military career took him all over the U.S. mainland and
11 Asia. He has been stationed in Washington, Hawaii, California, Texas, Colorado,
12 New Jersey, Oklahoma, and Korea. He has many accomplishments throughout his
13 military career, such as serving as a Drill sergeant at Fort Dix, New Jersey, from 1980
14 to 1982; as an Instructor at the Army Navy Academy in Carlsbad, California, from
15 1982 to 1985; and he completed the Sergeant Majors Academy at Fort Bliss in El
16 Paso, Texas, in 1991; and

17 **WHEREAS**, in July of 1992, Cecilio retired from the U.S. Army as a First
18 Sergeant (1SG) after serving in the military for twenty years. Soon after, he went on
19 to teach JROTC courses at the Guam Community College, *Inarajan* High School,
20 Southern High School, and currently at George Washington High School; and

21 **WHEREAS**, after his retirement, Cecilio and Agnes made their home in
22 *Malojloj*, and he has been an active parishioner at San Isidro Catholic Church ever
23 since. Throughout the years, Cecilio served in many parish ministerial duties, to
24 include serving as a CCD teacher, as a member of the Knights of Columbus, as a
25 lector, and as a member of the Finance and Parish Councils, and

26 **WHEREAS**, in September of 2014, Cecilio was diagnosed with Acute Myeloid

1 Lukemia (AML), and he later suffered a stroke in January of 2015. Even though he
2 has been ill, with God's grace and mercy, and prayers from everyone, he continues to
3 be a part of the Church parish. He strives to be stronger every day, so that one day he
4 may return to helping the parish community in his former duties; now therefore, be it


5 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Tres Na*
