1           **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***

3           **WHEREAS,** Christian Valencia moved to Guam with his family on July 24,  
4 2005, and is from the village of *Yigo*. He is the son of Cenon A.Valencia and  
5 Villaflor F. Valencia; and

6           **WHEREAS,** Christian is a member of the 2015 Graduating Class of Simon  
7 Sanchez High School; and his accomplishments include serving as President of the

1 Freshmen Academy (Tiger Sharks), and President and Founder of the Junior State of  
2 America (JSA), a Chapter that has grown to over forty (40) members and which he  
3 founded with the help of a teacher-advisor; and

4 **WHEREAS**, Christian is also President of the National Honor Society, and he  
5 has held this position for two (2) years; as well as being the Captain of the Academic  
6 Challenge Bowl, and President and Lead Attorney of the Mock Trial team; and

7 **WHEREAS**, Christian has maintained a position in the “A” Honor Roll since  
8 his freshman year, and he has been awarded for being an Outstanding Attorney and  
9 Witness in the Guam High School Mock Trial Competition. He was a recipient of the  
10 Department of Interior’s Full Scholarship for Junior State of America (JSA) Summer  
11 School at Stanford University in 2013, receiving an Honors Diploma; and he is a  
12 reporter and member of the Pacific Daily News VIBE Program and a recent honoree  
13 of the KUAM Care Force “Hope for Tomorrow” Award; and

14 **WHEREAS**, Christian is an avid saxophone player and currently plays in his  
15 school’s jazz band, specializing in alternative and indie music. He also leads the  
16 Ministry of Altar Servers at Our Lady of Lourdes Church; and

17 **WHEREAS**, Christian was most recently awarded with the prestigious Gates  
18 Millennium Scholarship, which allows him to pursue a degree in any undergraduate  
19 major and selected graduate programs at accredited colleges and universities. The Bill  
20 and Melinda Gates Foundation augments the importance of investing in the next  
21 generation of extraordinary scholars to support our country’s economic strength and  
22 competitiveness. When asked what motivates him, he said it comes down to family;  
23 and that while living in the Philippines, he lived in a poor community and it was  
24 difficult for his parents to put food on the table, but were still able to manage  
25 somehow; and his parents are his inspiration to do greater things; and

26 **WHEREAS**, although Christian may have had humble beginnings, his future is  
27 filled with infinite possibilities. He will be attending the College of the Holy Cross, in

1 Massachusetts, and plans to major in History and may also pursue a degree in Law  
2 and Education; and

3 **WHEREAS**, Christian dedicates all his hard work to his parents; and he  
4 expresses how it is all a reflection of his appreciation to them; now therefore, be it


