14 people of all ages and body types can be physically active. “National Health and  
15 Fitness Month” is a great time to spread the word about the benefits of being  
16 physically active. Communities, health professionals, and families can work together  
17 to create opportunities for everyone to get more physical activity; and to encourage  
18 families to make small changes, like taking a walk after dinner or going for a bike  
19 ride, as well as motivating teachers and administrators to make physical activity a part  
20 of every student’s day, and identifying youth leaders in the community who can talk

29 year; now therefore, be it


30           **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Tres Na*
