WHEREAS, Roque Tenorio Mantanona was born on November 9, 1931; and he was raised in the beautiful southern village of *Inarajan*. He married †Antonia Francisco Mantanona on November 22, 1952; and they moved to village of *Mangilao* where together they raised ten (10) children: Ramon, †Carmelita, Larry, Marie, Joseph, †David, Peter, Rosie, †Joaquin, and Ann. *Tun* Roque and *Tan* Antonia
 Mantanona were also blessed with forty-five (45) grandchildren, fifty-seven (57) great
 grandchildren, and a great-great grandchild; and

WHEREAS, *Tun* Roque is a Veteran who enlisted in the United States Army
and served in the Korean War. While serving in the Army, he was assigned to the
Fortieth (40th) Infantry Division; and he was a member of the U.S. Army Golden
Gloves Boxing Team and won the United States Army Golden Gloves Boxing
Championship in Santa Monica, California, in 1950; and

9 WHEREAS, Roque "Rocky" Mantanona, which he is known by the boxing 10 community because of his similarity to former boxing Heavyweight Champion of the 11 World Rocky Marciano, brought his love of boxing back home and he opened a 12 boxing gym at the *Paseo de Susana*, which is now known as the *Paseo* Stadium, and 13 trained some of Guam's most well known boxers; and

WHEREAS, *Tun* Roque started working at the Department of Corrections (DOC) on October 20, 1969; and he left the Department of Corrections to become a boxing coach with the Department of Parks and Recreation on September 4, 1979. He decided to return to the Department of Corrections on August 10, 1981; and he later retired from the DOC as a Captain on January 31, 1991; and

WHEREAS, *Tun* Roque always had a love for writing poetry, and many of his poems depicted his way of life and how it was for him growing up on the beautiful island of Guam. However, writing songs was his forte and he started making albums with Johnny Sablan in 1976; and

WHEREAS, *Tun* Roque, who is known for his love of *Chamorro* music, began composing songs for many aspiring local musical artists, such as JD Crutch, including the songs, "*Guinaifen Manglo*," "*Madandan I Kampana*," and "*Asaguahu Na Palaoan*" - which he wrote for his lovely wife, Antonia, after Typhoon Pamela in 1976, as he watched how hard she worked to care for their children; he had also
 composed the song, "*Puti Tai Nobio*" for Johnny Sablan and Flora Baza Quan; and he
 composed songs for many other artists, such as Bobbie Degracia, Sally Dueñas, Linda
 Guerrero and Francis Guerrero; and

5 WHEREAS, *Tun* Roque is fondly known by his loved ones and those close to 6 him for his broad sense of humor, his toughness, the love he had for his family, and 7 the desire to keep *Chamorro* music alive; now therefore, be it

8 **RESOLVED,** that the Committee on Rules of *I Mina'Trentai Tres Na* 9 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people 10 of Guam, recognize and memorialize the late Roque Tenorio Mantanona for his 11 invaluable contributions to the people of Guam; and does further extend sincere 12 condolences to his family on his passing; and be it further
