1 thirty (30) with the opportunity to experience fellowship through service to the people  
2 of Guam; and

3 **WHEREAS**, the outgoing Board Members for Rotary Year 2014-2015 are  
4 Christopher Surla, President; Russell Ocampo, Vice President; Candise Lizama,  
5 Secretary; Danny Harrell, Treasurer; Eileen Agahan, Immediate Past President; and  
6 Derrick Haynes, Sophie Brindejone, Lawrence Alcairo, Cabrini Rivera and Rose  
7 Serquina, Directors; and

8 **WHEREAS**, in the spirit of this year's Rotary theme, "Light Up Rotary," RAC  
9 Marianas continues to contribute to the community of Guam through its five avenues  
10 of service: club service, professional development, community service, international  
11 service and youth service; and

12 **WHEREAS**, by holding monthly meetings and community service events, both  
13 individually and in partnership with its sponsor clubs, the Rotary Club of *Tumon* Bay,  
14 the Rotary Club of Guam Sunrise, the Rotary Club of Guam, and the Rotary Club of  
15 Northern Guam, RAC Marianas has greatly contributed to the landscape of young  
16 professionals on Guam; and

17 **WHEREAS**, RAC Marianas hosted the first "Rotaract Youth Leadership  
18 Conference" in September 2014; and it was able to develop the leadership skills of  
19 dozens of students from the island's high schools that participated, bringing together  
20 many of the Integrators from the island's various Interact Clubs for the first time; and

21 **WHEREAS**, RAC Marianas hosted the first "Run Fast for the Cast" 5K Fun  
22 Run in April 2015, the proceeds of which were used for the benefit of the travel  
23 expenses of children and their caregivers under the care of the Guam Shrine Club, a  
24 non-profit organization that helps the caregivers of children with orthopedic, burn,  
25 cleft palate and spinal conditions to seek specialized care, not found in Guam, at the  
26 Shriner's Hospital for Children in Honolulu, Hawaii; and
