3 **WHEREAS,** Central Washington University (CWU) is located in Ellensburg,
4 Washington; and it is committed to hands-on learning and discovering by taking its
5 students beyond the limits of the classroom and studying and engaging in real-world
6 professional settings; and

1 **WHEREAS**, a team of three faculty members of the School of Public Health of
2 Central Washington University - Associate Professor in Physical Education Mark I.
3 Perez, Ph.D., Associate Professor in Physical Education Paul Stefan Ward, Ph.D., and
4 Assistant Professor in Physical Education Tishra Beeson, PH, MPH; six graduates -
5 Margarita Manzo-Casio of Sunnyside, Washington, Holly Pitzel of Black Diamond,
6 Washington, Erika Ojeda of Yakima, Washington, Lindsay Cristobal of Redmond,
7 Washington, Makenna Robinson of Bothell, Washington, and Caroline Dowdle of
8 Port Townsend, Washington; and two upperclassmen - Eric Evans of Ellensburg,
9 Washington, and Courtney Molenda-Cook of Seattle, Washington, arrived on Guam
10 to engage in an eight week study abroad, with service learning experiences centered
11 around health education and elementary education; and

12 **WHEREAS**, the CWU students, in collaboration with the University of
13 Guam's Adventure/Sports Camp, and the English Adventure Program; the Guam
14 Department of Public Health and Social Services (DPHSS) Senior Citizens Division;
15 and the Mayors' Offices of *Agaña Heights*, *Mangilao* and *Sinajana*, have prepared a
16 two week outreach program to conduct focus groups to showcase health education and
17 health concepts and teach health education lessons, and will also engage in a cultural
18 immersion experience; and

21 and Social Services that will support and contribute to each student's success; now

2 experiences here on Guam; and be it further


