10 Government of Guam working at the Department of Public Health and Social
11 Services; and

12 **WHEREAS**, throughout her career, Cecilia received numerous Letters of
13 Commendation, Certificates of Appreciation and Recognition, Outstanding
14 Performance Evaluations, and other recognitions for her efforts; and

15 **WHEREAS**, in 2008, at the request of the Centers For Disease Control in
16 Atlanta, Georgia, she provided technical assistance during the Multidrug Resistant
17 Outbreak in Chuuk State of the Federated States of Micronesia; and

18 **WHEREAS**, from 2004 until the present time, Cecilia’s career culminated in
19 her service as the Program Manager for the Tuberculosis/Hansen’s Disease Program;
20 and most recently, she served as the Acting Foreign Quarantine and Enteric Disease
21 Control Program Manager; and

22 **WHEREAS**, Mrs. Cecilia Arciaga’s success and professionalism is greatly
23 appreciated by her colleagues, who will surely miss her; and as she enters the ranks of
24 the retired class, she will enter into a new phase of her life spending more time with


9 **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules
