- 3 WHEREAS, Father Wilfred Ortigas Lorilla, also known as "Father Willy," was
- 4 born on September 17, 1944, in Lambunao, Iloilo, Philippines; and is the son of †Mr.
- 5 and †Mrs. Juan and Lourdes Sablon Ortigas Lorilla; and

1 WHEREAS, along with his brothers and sisters, †Ma. Charita O. Lorilla, 2 +Abelardo O. Lorilla, Ma. Vision O. Lorilla, Sister Consuelo O. Lorilla, +Aurelia O. 3 Lorilla, Teresa O. Lorilla, Simon O. Lorilla, Elena O. Lorilla, Rosario O. Lorilla and 4 Loreta O. Lorilla, Father Willy chartered a life-long path in pursuit of a Catholic education and a deepening Catholic faith, first attending Calumpit Elementary School 5 6 in Calumpit, Bulacan, and then completing his secondary education at the Seminario 7 de San Jose in Puerto Princesa City; and later, he obtained a Baccalaureate in Theology from the Saint Vincent Ferrer Major Seminary in Jaro, Iloilo City; and 8

9 WHEREAS, Father Willy's thirst for further edification led him to enroll in 10 higher education studies at the University of San Agustin (USA) in Iloilo City, where 11 he earned a Bachelor of Science in Education (B.S.E.), and a Master of Arts (M.A.) 12 with a Major in Psychology; and

WHEREAS, Father Willy O. Lorilla was ordained as a priest on April 28,
14 1968, at the Immaculate Conception Cathedral in Puerto Princesa City, Palawan, by
15 the †Most Reverend Gregorio Espiga, OAR, DD, Apostolic Vicar of Palawan; and

WHEREAS, Father Willy's early ministry would utilize his teaching skills, as
Father Willy began the first seven (7) years of his ministry serving as a Professor and
Principal at the Seminario de San Jose in Puerto Princesa City, Palawan, from 1968
until 1975. In 1975, he joined his alma mater at the University of San Agustin (USA)
in Iloilo City, where he served as a Professor for twelve (12) years until 1987; and
concurrently until 1988, he served as a Resident Priest at the Saint Elizabeth of
Hungary Cathedral in Jaro, Iloilo City; and

WHEREAS, with a balance of service in education and faith, Father Willy began the first six (6) years of his ministry on Guam serving as the Parochial Vicar of the Santa Barbara Catholic Church Parish in *Dededo*, from 1988 until 1994; and

1 WHEREAS, in 1994, Father Willy O. Lorilla became the Pastor of the 2 Assumption of Our Lady Catholic Church Parish in *Piti*, where he has faithfully 3 served until the present time; and

WHEREAS, Father Willy O. Lorilla inspired the attendees with his talk on
"His Mercy Endures Forever" (Psalm 136:1), during the first "Guam Divine Mercy
Congress," which was held at the Santa Barbara Catholic Church in *Dededo* on
October 5, 2013, marking an unprecedented event in our local Catholic Church history
that will surely be long remembered in the hearts and minds of many of the Catholic
faithful who attended; and

WHEREAS, with a total of twenty-seven (27) years of dedication, faithfulness and distinguished service, Father Wilfred Ortigas Lorilla is deserving of much gratitude and appreciation for his invaluable contributions to the Catholic faithful of Guam; now therefore, be it
