2 L. Ericson and the late Virginia D. Ericson; and is the stepdaughter of Margaret
3 Ericson; and

4 **WHEREAS**, the late Dr. Debra Gail Ericson, M.D., is married to Dr. Walter
5 Chris Perez, M.D., and they have two children, Kallen Marie and Matthew Gregory; a
6 son-in-law, Brandon Bamba; and a grandchild, Nolan Christopher; and

7 **WHEREAS**, the late Dr. Debra Gail Ericson, M.D., attended public school in
8 Southern California, and she graduated with honors in 1970 from Pomona High
9 School; and

11 University of Redlands in 1974 with a Bachelor of Science in Biology degree; and

12 **WHEREAS**, the late Dr. Debra Gail Ericson, M.D., graduated from the
13 University of California San Francisco School of Medicine, where she earned her
14 medical degree in 1978; and

15 **WHEREAS**, the late Dr. Debra Gail Ericson, M.D., was recognized in the
16 medical community for her outstanding contributions to the health and welfare of
17 Guam's people, and she had practiced family medicine for 30 years at "The Doctors'
18 Clinic" in *Tamuning*, and was also one of its founders in 1985; and

19 **WHEREAS**, the late Dr. Debra Gail Ericson, M.D., had also worked at the
20 Guam Department of Public Health and Social Services for several years; and

21 **WHEREAS**, the late Dr. Debra Gail Ericson, M.D., was an active member of
22 the Guam Medical Society and the Guam Medical Association, and was a Fellow of
23 the American Academy of Family Practice, and a Diplomate of the American Board
24 of Family Medicine; and

1 **WHEREAS**, the late Dr. Debra Gail Ericson, M.D., served as a staff physician
2 at the Guam Memorial Hospital since 1981, and was the former Chairperson of the
3 Family Practice Department; and

4 **WHEREAS**, the late Dr. Debra Gail Ericson, M.D., was the Chairperson of the
5 Guam Memorial Hospital’s Continuing Medical Education Committee, where she
6 received the “Outstanding and Dedicated Service Award”; now therefore, be it


7 **RESOLVED**, that *I Mina'Trentai Tres Na Liheslaturan Guåhan* does hereby,
