3 **WHEREAS**, in 1984, Francis John Francisco started his government of Guam
4 career working as a limited term employee with the Real Property Tax Division of the
5 Department of Revenue and Taxation (DRT); and

1 **WHEREAS**, Mr. Francis John Francisco attended the University of Guam from
2 1982 through 1984; and

3 **WHEREAS**, while serving in the DRT Real Property Tax Division, Francis
4 simultaneously performed the duties of an Assessment Officer; and he was then
5 assigned to work as an Office Manager overseeing the Counter Service Section; and

6 **WHEREAS**, by 2003, Francis had moved up the ranks, and he served with the
7 Tax Enforcement Division's Collection Branch; and

8 **WHEREAS**, while serving as a Revenue Officer III of that Division, Francis
9 was instrumental to its mission and he assisted in the field work activities. He was
10 assigned to handle bankruptcy cases where he balanced the interest of the debtor and
11 the government of Guam, and he is highly viewed as a specialist in this field; and

12 **WHEREAS**, through his tireless efforts, Francis assisted and provided
13 guidance to his colleagues, while meeting the goals and mission of the Department;
14 and

15 **WHEREAS**, Francis' quality of direction and consultation are highly regarded
16 by his colleagues who worked closely with him during his tenure with the
17 Department; and

18 **WHEREAS**, Francis John Francisco comes from a family that has dedicated
19 their lives to serving at the Department of Revenue and Taxation, including his
20 deceased father, Juan C. Francisco, and his mother, Rosa Q. Francisco, who retired
21 from the Department of Revenue and Taxation Collection Branch in 1990; and

22 **WHEREAS**, Francis John Francisco will be retiring after thirty (30) years of
23 dedicated public service to the government of Guam while working at Department of
24 Revenue and Taxation; now therefore, be it

25 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Tres Na*
26 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people


1 of Guam, recognize, commend and congratulate Francis John Francisco on the
