2 boonie pepper, which serves as an integral part of Guam’s culture and has steadily
3 become a culinary staple that adds flavor and spice to a wide assortment of Guam’s
4 local cuisine; and

5 **WHEREAS**, the inaugural “*Mangilao Donne’* Festival” was part of the Guam
6 Visitors Bureau’s (GVB) “We Are Guam” branding initiative and marketing
7 campaign, which focused on highlighting certain cultural aspects that make Guam,
8 and its people, special and unique; and

9 **WHEREAS**, the “*Mangilao Donne’* Festival” is a great opportunity for the
10 residents of *Mangilao* and the people of Guam to come together and demonstrate the
11 different uses of *donne’* and its significance to Guam’s culture, and to showcase the
12 ingenuity and entrepreneurial spirit of our people; and

13 **WHEREAS**, the festivities for the 2015 “*Mangilao Donne’* Festival” will
14 include cooking contests featuring the *donne’* as a main ingredient, a contest to choose
15 the most beautiful *donne’* plant, the crowning of the 2015 “Little Miss *Mangilao*
16 *Donne’* Festival,” entertainment and performances from different community groups
17 and organizations, and various merchandise vendors; and

18 **WHEREAS**, the “*Mangilao Donne’* Festival” serves as an incubator for small
19 businesses and gives an opportunity for members of our community to showcase their
20 products and talents to other local residents and to visitors from around the world; and

21 **WHEREAS**, the “*Mangilao Donne’* Festival” continues to grow every year,
22 attracting Guam residents and visitors to the municipality of *Mangilao* to enjoy food,
23 entertainment, and contests; and


24 **WHEREAS**, initiatives, such as the “*Mangilao Donne’* Festival,” promote
25 small business economy and a prosperous economic future by offering the people of

1 Guam through their own hard work, the opportunity to test the commercial viability of
2 their products and talent; now therefore, be it


3 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Tres Na*
