3 **WHEREAS, Mr. Edwin Servano Verzosa celebrates his retirement with his**
4 **wife, Mrs. Susan Ganon Verzosa; and his three (3) children, Tracy Ann, Sharlene, and**

1 **WHEREAS**, on October 8, 1985, Mr. Edwin Servano Verzosa began his
2 government of Guam career in public service to the people of Guam, working as a
3 Research and Administrative Assistant with the External Trade Section, Economic
4 Research Center of the former Department of Commerce; and

5 **WHEREAS**, after working with the Department of Commerce for a little over a
6 year, Mr. Verzosa was promoted to the position of Statistical Clerk on July 25, 1986;
7 and held this position for five (5) years. He showed much dedication and commitment
8 to his work and on October 21, 1991, he was promoted, to serve as a Statistical
9 Technician II; and

10 **WHEREAS**, proving himself as a good public servant, he swiftly worked his
11 way up the ranks with the Department of Commerce for almost a decade; and showing
12 great spirit and teamwork, he was again promoted to serve as a Statistician II and
13 External Trade Section Supervisor, where he was responsible for collecting trade data
14 and reporting about the dollar valuations of goods imported and exported through
15 Guam; and

16 **WHEREAS**, when Public Law 26-76 was passed and enacted in 2002, the
17 Economic Research Center was transferred to the Bureau of Statistics and Plans; and

18 **WHEREAS**, from March 13, 2002 to the present, Mr. Edwin Servano Verzosa
19 served as a Statistician II and External Trade Section Supervisor with the Bureau of
20 Statistics and Plans/External Trade Section, Business and Economic Statistics
21 Program, where he received a notable award, the 2013 MagPro Award: Employee of
22 the Year, Statistics and Economics; and

23 **WHEREAS**, Mr. Edwin Servano Verzosa is a devoted Catholic who has regular
24 meals with his wife at restaurants; he raises home pets and roosters; he is an avid cock
25 fighting fan; and he enjoys watching local and international competitive sporting
26 events; and

1 **WHEREAS**, Edwin’s plans after retirement include spending quality time with
2 his wife as they love spending time together at restaurants and social events; as well as
3 to continue to raise roosters and home pets, attend occasional cock fighting events,
4 and possibly travel to the United States and Philippines to visit family and friends;
