3           **WHEREAS, Cecilia A. Aquino was born on November 9, 1958; and is the**  
4           **daughter of the late Mr. and Mrs. Francisco A. and Teresa G.A. Acfalle; and**

1           **WHEREAS**, Cecilia A. Aquino attended *Adelup* Elementary School, *Piti*  
2 Elementary School, *Agat* Junior High School, and George Washington High School;  
3 and

4           **WHEREAS**, Cecilia married Samuel Quitugua Aquino on December 7, 1979;  
5 and they have three (3) children: Mark Anthony Aquino, who is married to U.S. Army  
6 Major Vanessa Nisperos Mayo Aquino; Nikita Teresa Aquino; and Celina Elidia  
7 Acfalle Aquino; and they are also blessed with three (3) grandchildren: Khlo'e Thela  
8 Aquino Inciong, Ethan Kole Aquino Inciong, and Logan Eli Mayo Aquino; and

9           **WHEREAS**, on January 30, 1978, Cecilia A. Aquino began her government of  
10 Guam career working as a Clerk Typist I with the Governor's Office on a limited term  
11 appointment; and served with the Public Defender Service Corporation (PDSC) from  
12 January 2 to March 15, 1979; and she then worked as a Front Office Legal Clerk  
13 under the Land Claims Program of the PDSC from August 1979 to February 1980;

15           **WHEREAS**, from February 1980 to June 1985, Cecilia A. Aquino lived off  
16 island with her husband Sam, who was serving in the U.S. Army during that time; and  
17 while serving his military duty, they were stationed in Texas, Washington, and  
18 Germany before returning to Guam in 1985; and

19           **WHEREAS**, after returning to Guam, Cecilia A. Aquino took on employment  
20 again with the PDSC, serving as a Receptionist from September 16, 1985; as a  
21 Secretary from February 3, 1986; and as a Secretary Typist II from October 31, 1986;

23           **WHEREAS**, Cecilia A. Aquino continued to advance in her career with the  
24 PDSC, and began working as an Administrative Secretary II from May 4, 1987; as a  
25 Legal Secretary I from September 21, 1987; as a Legal Secretary II from June 19,  
26 1989; and as a Legal Secretary III from February 28, 1994; and


1           **WHEREAS**, during her tenure with the PDSC, Cecilia A. Aquino was  
2 recognized with the Meritorious Award for her exemplary performance; and

3           **WHEREAS**, since February 1994, Cecilia A. Aquino served in the position of  
4 Legal Secretary III at the PDSC until her retirement, which became effective on  
5 September 18, 2015; now therefore, be it


6           **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Tres Na*
