3 **WHEREAS, Vicente F. Duenas, Jr., has dedicated more than twenty-five (25)**
4 **years to government of Guam service while working at the Judiciary of Guam; and on**

1 September 30, 2015, he will be celebrating his retirement with his daughter, Madison
2 I.A. Duenas; and

3 **WHEREAS**, in October 1990, Mr. Duenas started his public service career
4 working at the Judiciary of Guam as a Deputy Marshal II. Prior to this, he had
5 completed the Basic S.W.A.T., Police and Responder Training, as well as numerous
6 law enforcement courses. Mr. Duenas also received his Bachelor of Science in
7 Criminal Justice; and

8 **WHEREAS**, through hard work and dedication, Vicente continued to work his
9 way up the ranks, and he was promoted to the position of Probation Officer II in
10 November 1992. In September 1994, he was promoted again to serve as a Probation
11 Officer III; and on September 20, 1996, his position was reclassified to Senior
12 Probation Officer, and since then he has held this position; and

13 **WHEREAS**, Mr. Duenas had also received extensive training and qualification
14 courses throughout his years working with the Judiciary, such as Basic Firearms
15 Trainings, Survivors Training, Substance Abuse Awareness and Drug Screening
16 courses, and numerous Firearms Qualifications Courses; and

17 **WHEREAS**, throughout his years serving at the Judiciary of Guam, Mr.
18 Duenas received various commendations and recognitions, such as: a Letter of
19 Commendation for the grand opening of the Guam Judicial Center in 1991; a Letter of
20 Appreciation and Commendation for his participation in the Guam Judicial Choir; a
21 Letter of Appreciation for attending the 12th Island Conference on Public
22 Administration; and recognition for his civic contributions to the community as a
23 member of the Guam Island Chorale in 1999; and

24 **WHEREAS**, the 33rd Guam Legislature and the people of Guam would like to
25 thank Mr. Duenas for the many years of service he has provided to our island, and

1 wish him well in his future endeavors and enjoyment in his retirement; now therefore,
2 be it
