1 **WHEREAS**, Mrs. Tenorio further served with the Guam Legislature in the
2 Office of Senator Jerry Rivera from March 1988 to March 1989; and

3 **WHEREAS**, Mrs. Tenorio then served in the External Trade Section of the
4 former Department of Commerce, working as a Statistical Clerk from June 1989 to
5 March 1995; and

6 **WHEREAS**, Mrs. Tenorio became a Statistical Technician II, and she provided
7 professional support to the Census and Population Section of the Department of
8 Commerce from March 1995 to August 1996; and

9 **WHEREAS**, Mrs. Tenorio continued in her service as a Statistical Technician
10 II from August 1996 to July 2007 working in the Cost of Living Section of the
11 Department of Commerce while witnessing the change of the name of the department
12 to the Bureau of Statistics and Plans in 2002; and

13 **WHEREAS**, Mrs. Tenorio took on additional duties and served as a Statistician
14 II, and in an acting capacity as the Cost of Living Section Supervisor of the Business
15 and Economics Statistics Program of the Bureau of Statistics and Plans from July
16 2007 to January 2008; and

17 **WHEREAS**, from January 2008 to September 2015, Mrs. Tenorio served in the
18 position of Statistician II and as the Cost of Living Section Supervisor of the Business
19 and Economics Statistics Program of the Bureau of Statistics and Plans; and

20 **WHEREAS**, Mrs. Tenorio now celebrates this milestone of her retirement in
21 with her children, Camarin Marie and Austin Michael, and especially acknowledges
22 her late husband, Mr. Roke Borja Tenorio, whom she married on July 11, 1994; and

23 **WHEREAS**, Mrs. Tenorio will join the ranks of the retired class, enjoying her
24 time to maintain her faith and familial values, as she is a woman of strong religious
25 and family values, travelling, and visiting family and friends abroad while caring and
26 attending to the needs of her immediate family; and
