- 3 Insurance Limited; Frank Campillo, Health Plan Administrator, and many others, lead
- 4 the organization in providing medical insurance coverage to over thirty-eight thousand
- 5 (38,000) members; and
- 6 WHEREAS, the SelectCare medical plan allows access to more than one
- 7 hundred (100) physicians and clinics in the region, as well as to more than three
- 8 hundred fifty thousand (350,000) health care providers in the United States and the
- 9 Philippines; and
- WHEREAS, the SelectCare Plan was originally insured by Nichido Insurance;
- and then in 2004, it merged with Tokio Marine and formed a local Guam company,
- 12 Tokio Marine Pacific Insurance (TMPI), becoming a subsidiary of Tokio Marine
- 13 Holdings, a global insurance conglomerate; and
- WHEREAS, Tokio Marine Pacific Insurance is the only AM Best rated health
- insurer on Guam, is rated A+, and employs twenty (20) Guam residents; and
- 16 WHEREAS, SelectCare introduced the first web-based application for its
- 17 members' use; and
- 18 WHEREAS, SelectCare insures the Government of Guam employees and
- 19 retirees, the Federal employees and annuitants, and various commercial groups in
- Guam, the CNMI and Palau; and
- WHEREAS, SelectCare opened an office in Koror, Palau, in 2006; and it
- 22 opened a service office in Manila in 2007; and
- WHEREAS, SelectCare became the sole provider of health insurance benefits
- 24 for the Government of Guam in 2008 due to the departure of other carriers from this
- 25 market; and

1 WHEREAS, SelectCare was approved to offer health insurance benefits to the 2

Federal employees and annuitants starting with the 2013 calendar year; and

WHEREAS, SelectCare has introduced unique health insurance offerings to the market, such as the high deductible health plan that allows Health Savings Accounts, and the Philippine only plan, along with introducing wellness programs with partnerships that include the SDA Clinic, Paradise Fitness, and Synergy in 2009; and

WHEREAS, SelectCare continues its efforts in preventing illness by introducing the free gym benefit for GovGuam employees, deep discounted gym memberships for commercial groups, and comprehensive wellness programs that include smoking cessation, diabetes management, and access to gym partners; and

WHEREAS, SelectCare offers a life saving Air Ambulance discount program to all insured members; and it continues to provide a high-level of service to the people of Guam with a wealth of programs, including wellness and health initiatives, and its Air Ambulance program has already saved ten (10) lives; and

WHEREAS, since its establishment, Selectcare has been a community partner and collaborator on many health initiatives, including its participation in the Worksite Non-Communicable Governor's Wellness Program, the Disease Consortium, and numerous other activities of local, community-based organizations it has supported; and

WHEREAS, SelectCare is very generous in its nature, and has given donations to many local organizations, including the Guam Memorial Hospital Volunteers Association, which in turn has used these donations to purchase critically-needed hospital equipment for the Guam Memorial Hospital; now therefore, be it
