23 of the Year” and he received the “Mag Pro Award” two (2) years in a row; and


24 **WHEREAS**, in May of 2014, William received an additional meritorious

3 cars; and to truly enjoy retirement with his family; now therefore, be it


4 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Tres Na*

14 *Maga'låhen Guåhan*.


