

1        **BE IT RESOLVED BY *I MINA'TRENTAI TRES NA LIHESLATURAN***  
2 ***GUÁHAN*:**  
3        **WHEREAS,** Public Law 32-226 directs the *Chamorro* Land Trust Commission  
4 to select a suitable lot to exchange to the Department of Public Health and Social

1 Services from property reserved for its use with property owned by the *Chamorro*  
2 Land Trust Commission; and

3 **WHEREAS**, the *Chamorro* Land Trust Commission has selected and approved  
4 Tract 9, Block F, Lot 14, *Barrigada*, with an area of 10,049.75 square meters, for the  
5 land exchange; now therefore, be it

6 **RESOLVED**, that *I Mina'Trentai Tres Na Liheslaturan Guåhan* does hereby  
7 accept Tract 9, Block F, Lot 14, *Barrigada* for the land exchange required by Public  
8 Law 32-226; provided that, if construction of the contemplated Foster Care Home  
9 does not commence within three (3) years of the enactment of this Act, Tract 9, Block  
10 F, Lot 14, *Barrigada shall* revert to the inventory of the *Chamorro* Land Trust  
11 Commission; and be it further

12 **RESOLVED**, that the Speaker certify, and the Legislative Secretary attest to,  
13 the adoption hereof, and that copies of the same be thereafter transmitted to the  
14 Chairperson, Committee on Rules of *I Mina'Trentai Tres Na Liheslaturan Guåhan*;  
15 and to the Honorable Edward J.B. Calvo, *I Maga'lahren Guåhan*.


