11 Carlos had received extensive training courses, such as: basis position classification,
12 supervisory and leadership training, employment power, and court management, to
13 name a few; and she had also received her Bachelor's degree in Business

15 **WHEREAS**, while serving at the Judiciary of Guam, Mrs. Carlos received
16 numerous Certificates of Appreciation from the Pacific Juvenile/Judicial Conference
17 Committee, the Awards Program Committee, and the School-To-Work Program
18 (1992-2002). She had also received Certificates of Nomination from Honoring the
19 Silent One (2006-2007); and

3 Filipino community organizations on Guam; and


4 **WHEREAS**, the 33rd Guam Legislature and the people of Guam would like to

6 wish her well as she enjoys her retirement; now therefore, be it


7 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Tres Na*
