7 in Texas, in July 2003; and her professional background includes serving in various
8 roles within the health services administration, including Outpatient Records
9 Technician, Information Systems Technician, Medical Office Manager, Medical
10 Control Center NCO, and NCOIC of Patient Administration; and

11 **WHEREAS**, on January 29, 2009, Second Lieutenant My-Randa Kelly Quinata
12 married Derrick Muna Quinata; and they are the proud parents of four (4) children:
13 Taylor, Trevor, Talon and Tana; they also have two (2) pet dogs: Shilo and Dollar;

15 **WHEREAS**, Second Lieutenant My-Randa Kelly Quinata's military education

24 Trident University International in Cypress, California, in 2013; and

3 to December 2006; Health Services Journeyman, at Andersen Air Force Base, Guam,
4 from December 2006 to September 2014; and Guam Air National Guard from

6 **WHEREAS**, during her twelve (12) years of active duty, Second Lieutenant
7 My-Randa Kelly Quinata served at Lackland Air Force Base, Texas, and at Andersen
8 Air Force Base, Guam; and she was deployed once to Ali Al Salem Air Base in
9 support of Operations in Iraq and Afghanistan; and

10 **WHEREAS**, in 2014, Second Lieutenant My-Randa separated from active
11 military duty to continue her career in the civilian sector. She serves as a Health
12 System Specialist for the federal government at Andersen Air Force Base, Guam, and,

14 Operations Medical Cell. Second Lieutenant My-Randa Kelly Quinata also
15 transitioned into the Guam Air National Guard, and is assigned to the 254th Force

5 2015); now therefore, be it


6 **RESOLVED**, that *I Mina'Trentai Tres Na Liheslaturan Guåhan* does hereby,
