3           **WHEREAS**, on March 27, 1972, the American Sotetsu Corporation was  
4 established; and later that year, the construction of the *Tumon Sands Plaza* began on  
5 October 30, 1972; and

1           **WHEREAS**, approximately a year later, the main building of the *Tumon* Sands  
2 Plaza opened in December of 1973; and

3           **WHEREAS**, the *Tumon* Sands Plaza quickly expanded with the opening of the  
4 famous “*Joinus* Restaurant” along with a total of thirty-six (36) hotel rooms on the 3<sup>rd</sup>  
5 floor in January of 1974; and

6           **WHEREAS**, the *Tumon* Sands Plaza opened up twenty (20) arcade shops in  
7 April of 1974; and

8           **WHEREAS**, in the years that followed a number of other stores opened up to  
9 include Tiffany & Co. in 1992; the Restaurant Annex in 1993; the Chanel Building in  
10 1994; and the Louis Vuitton Building in 1997; and

11           **WHEREAS**, the expansion of the *Tumon* Sands Plaza continued with the  
12 opening of the new Louis Vuitton Building in 2005; and in the same year, a company  
13 named the Mills Group acquired the *Tumon* Sands Plaza in January of 2005; and

14           **WHEREAS**, seven (7) years later, the ownership of the *Tumon* Sands Plaza  
15 changed with the acquisition of the *Tumon* Sands Plaza by S199 Real Estate, LLC; on  
16 November 9, 2012; and

17           **WHEREAS**, the *Tumon* Sands Plaza is located in the heart of beautiful *Tumon*  
18 Bay, and features more than twenty (20) world famous luxury brands arranged in a  
19 boutique atmosphere; and is also home to Anteprema, Paul Smith, Givenchy and  
20 Balenciaga, the only location on the island; and

21           **WHEREAS**, at the *Tumon* Sands Plaza, you will find the Louis Vuitton Global  
22 Store, as well as, boutiques for Tiffany & Co., Rolex, Gucci, Chloe, Marc by Marc  
23 Jacobs, Furla, Bally, Dunhill, Cartier, Bulgari, and Bottega Veneta; now therefore, be

4 with a relaxing and luxurious shopping and dining experience; and be it further


5 **RESOLVED**, that the Speaker certify, and the Legislative Secretary attest to,
