3 **WHEREAS,** for over 100 years, the American Cancer Society is the
4 nationwide, community-based, voluntary health organization dedicated to eliminating

1 cancer as a major health problem by preventing cancer, saving lives, and diminishing
2 suffering from cancer, through research, education, advocacy, and service; and

3 **WHEREAS**, the Guam Chapter of the American Cancer Society was organized
4 in 1969 and officially filed to serve the people of Guam in 1970, providing our island
5 with prevention, research, education and advocacy for 46 years; and **with the** mission
6 to support and educate the people of Guam on the harsh realities of cancer and what it
7 does to every human being; and

8 **WHEREAS**, the American Cancer Society held its first Relay For Life event in
9 Washington in 1985 and celebrated 30 years of Relay; and

10 **WHEREAS**, the Guam Chapter of the American Cancer Society quickly
11 followed suite and launched Guam’s first Relay For Life event soon after in 1988; and

12 **WHEREAS**, the Relay For Life is an annual event bringing thousands of Guam
13 residents together to raise funds that benefit the Guam community and the national
14 community to fulfill the mission of the Society; and

15 **WHEREAS**, “Paint Guam Purple” is the theme for the 2016 Relay For Life;

16 **WHEREAS**, purple is the signature color of Relay For Life and symbolizes the
17 passion to eradicate all cancers; and

18 **WHEREAS**, the Guam Chapter of the American Cancer Society is gearing up
19 to get the community to “Paint Guam Purple,” encouraging the island to embrace and
20 commit to support each of Guam’s cancer patients, their families, and caregivers, from
21 every mother, father, son, daughter, friend, and neighbor on Guam; and

22 **WHEREAS**, the Guam Chapter of the American Cancer Society encourages
23 the island community to stand with each cancer patient, to bring a sense of hope and
24 support in the constant fight to survive; and to bring awareness to the community and
25 continue to build the support each patient needs; and

1 **WHEREAS**, the Guam Chapter of the American Cancer Society is to be
2 commended for its relentless energy in fostering a spirit of family amongst all cancer
3 patients and supporters; and

4 **WHEREAS**, the Guam Chapter of the American Cancer Society is to be
5 commended for its commitment to research and advocacy that saves lives and
6 improves the quality of life for members of our community.

7 **WHEREAS**, the resilient spirit of our island people in the face of adversity is
8 echoed in the heart, soul, will and passion of each survivor and continues to renew
9 and inspire the community to fight with them; and now, be it

10 **RESOLVED**, that *I Liheslaturan Guåhan* supports the mission of the Guam
11 Chapter of the American Cancer Society to CELEBRATE, REMEMBER and FIGHT
12 BACK with paint brush in hand, to FINISH THE FIGHT, and to CREATE A
