3 sisters and their families; and

4           **WHEREAS**, the late Pedro Fujikawa San Nicolas is a veteran of our  
5 nation’s armed forces having served in the U.S. Army from September of 1976  
6 to September of 1979; and

7           **WHEREAS**, the late Pedro Fujikawa San Nicolas is a graduate of the  
8 University of Guam where he earned his Bachelor of Business Administration  
9 degree in Marketing; and

10           **WHEREAS**, in January of 2003, the late Pedro Fujikawa San Nicolas  
11 entered government of Guam service and worked with the Guam Power  
12 Authority as a Buyer II; and in March of 2004, he laterally transferred to the  
13 General Services Agency under the Department of Administration; and

14           **WHEREAS**, during his tenure with the General Services Agency, the late  
15 Pedro Fujikawa San Nicolas was periodically called upon to temporarily assume  
16 positions of greater responsibility, to include Buyer Supervisor, Assistant Chief  
17 Procurement Officer, and Chief Procurement Officer; and

18           **WHEREAS**, the late Pedro Fujikawa San Nicolas’ abilities,  
19 professionalism, dedication and commitment to his duties were recognized  
20 government-wide through his selection as the “Employee of the Year” by the  
21 Executive Branch’s MagPro Awards Program; and

22           **WHEREAS**, Pedro’s family, friends, co-workers, and all who knew him  
23 mourn the passing of the late Pedro Fujikawa San Nicolas; now therefore, be it
