1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***
2 ***MINA'TRENTAI TRES NA LIHESLATURAN GUÁHAN:***

3 **WHEREAS,** the Korean Women's Association of Guam (KWAG) was
4 established on June 25, 1975, as a non-profit organization, whose mission is to

1 advocate international goodwill and conformity, and to foster unity and solidarity
2 among Korean women, while encouraging the Korean culture to remain strong
3 throughout the community of Guam; and

4 **WHEREAS**, during the past thirty-nine (39) years, the Korean Women's
5 Association of Guam has been committed to addressing the humanitarian needs of our
6 island and abroad, and they have been recognized both locally and internationally for
7 their hard work, dedication, and the numerous outreach programs that offer assistance
8 to those less fortunate, the elderly and sick, and those who have been victimized by
9 domestic violence; and

10 **WHEREAS**, as a non-profit organization, the sources of KWAG funds are
11 membership fees, membership being open to any married Korean woman residing on
12 Guam; aid from the Korean Consulate General; the generous donations from
13 businesses around the island; and the annual Christmas Charity Gala and Mother's
14 Day festivities, which are hosted by the Association; and

15 **WHEREAS**, the Korean Women's Association of Guam has contributed
16 immensely to the Guam Memorial Hospital, toward improvements of its facility, and
17 towards the purchase of an Endoscope, wheelchairs and other equipment for the
18 Urgent Care Clinic; and KWAG has rendered much support to the Guam Memorial
19 Hospital Volunteer Association. Since its inception KWAG has donated generously
20 to various charities, such as the Alee Shelter, the American Cancer Society, the Guam
21 Chapter of the American Red Cross, *Guma' Mami* Inc., the Korean School of Guam,
22 the Korean Senior Association of Guam, the Salvation Army Guam Corps, the
23 Shriners Hospital for Children, the Special Committee to Support the Homeless, the
24 HOPE Foundation, scholarships to attend the University of Guam, and the *Rigalu*
25 Foundation; and


26 **WHEREAS**, the KWAG has made a positive impact on our island through its
27 generous contributions, and KWAG continues to strengthen the Korean pride and

1 culture within our community. The members of KWAG have dedicated their time,
2 efforts, and resources in serving the people of Guam since the organization has been
3 initiated, and they will continue in that mission for many years to come; now
4 therefore, be it


5 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Tres Na*
6 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people
7 of Guam, recognize and commend the Korean Women's Association of Guam on the

9 extend *Un Dångkolo Na Si Yu'os Ma'åse'* to its members for the tremendous service
