2 ***GUÁHAN*:**
3 **WHEREAS**, Mr. Danny H. Jackson, also known as “*I Maga'lahen Pågat*,” has
4 served *I Nasion Chamoru* since July 21, 1991; and

1 **WHEREAS**, in recognition of his devotion to the preservation, perpetuation,
2 and enrichment of the *Chamorro* culture, on May 29, 2010 *I Nasion Chamoru* elected
3 *Pågat* to be its *Maga'låhi*; and

4 **WHEREAS**, *Pågat* continues in his tireless efforts to see the *Chamorro* Land
5 Trust realize its true mandate of giving landless *Chamorros* property on which they
6 could build a home or farm; and

7 **WHEREAS**, *Pågat* has also supported the efforts of the Guam Ancestral Lands
8 Commission to return unneeded parcels of property to the original landowners, or to
9 provide compensation to them if the property cannot be returned because it is
10 necessary for a public use; and

11 **WHEREAS**, on January 14, 2014, the members of *I Nasion Chamoru*, in their
12 appreciation for his continuing contributions to its causes, re-elected Mr. Danny H.
13 “*Pågat*” Jackson to serve a second (2nd) consecutive term as its *Maga'låhi*; and

14 **WHEREAS**, *Pågat's* role in the fight against the use of *I Sengsong Pågat* to be
15 the site of a military firing range was recognized by the 32nd Guam Legislature in
16 Resolution No. 423-32(COR), adopted on August 27, 2014; and his continuing
17 advocacy of indigenous fishing rights has been evident in each and every forum on
18 this sensitive subject; and

19 **WHEREAS**, *Pågat's* efforts are shared and encouraged by Josephine, his wife
20 of forty-one (41) years; their three (3) sons, Kevin, Oscar and Steve; their
21 grandchildren, Gavin, Amber, Aaliyah, Teeana, Cason, Magahet, and Chaife; and
22 their great grandchildren, Avery and Giavonnie; now therefore, be it

23 **RESOLVED**, that *I Mina'Trentai Tres Na Liheslaturan Guåhan* does hereby,
24 on behalf of the people of Guam, recognize Mr. Danny H. “*Pågat*” Jackson for his
25 continuing contributions to the preservation, perpetuation and enrichment of the
26 *Chamorro* culture as a member of *I Nasion Chamoru*; and does further extend *Un*

1 *Dangkolo Na Si Yu'os Ma'åse'* to *Pågat* and commend him for being re-elected to a
2 second (2nd) consecutive term as *Maga'låhi* of *I Nasion Chamoru*; and be it further
3 **RESOLVED**, that the Speaker certify, and the Legislative Secretary attest to,
4 the adoption hereof, and that copies of the same be thereafter transmitted to Mr.
5 Danny H. "*Pågat*" Jackson; and to the Honorable Edward J.B. Calvo, *I Maga'låhen*
