5 **WHEREAS**, for over thirty (30) years, the USTAOG has fulfilled many
6 community outreach programs by providing contributions to the Guam and the
7 Filipino communities, to include projects in the area of health care. With their
8 tremendous spirit of volunteerism, they have brought immeasurable humanitarian
9 efforts through coordinating free medical services and monetary support for disaster
10 victims in the Philippines, as well as extending assistance to various charities on
11 Guam; and

12 **WHEREAS**, the various charitable projects that have promoted the spirit of
13 Thomasian include: conducting medical missions to help the residents of Gill Baza,
14 Swamp Road, Harmon Industrial Park, and Hemlani Apartment in Harmon; feeding

16 Care Home in *Barrigada*; scholarship awards to indigent and deserving Guam
17 students (in 2014, they awarded \$500.00 each to two deserving students attending

19 monetary donations to the Philippine Red Cross in the aftermath of the disaster and
20 calamities caused by Super typhoon Yolanda and the strong earthquake; monetary
21 donations to the UST Office of Alumni Relations in Manila, Philippines, in support of
22 their community project, "*Simbahayan*"; and
