Incorporated, was founded to improve the moral, mental, social and general welfare of
all Government of Guam retirees and senior citizens; and

WHEREAS, the Government of Guam Association of Retired Persons,
Incorporated, has promoted the work and success of Guam's retirees, ensuring the
promotion of their contributions to our island's history; and

WHEREAS, in 1989, the Government of Guam Association of Retired Persons, Incorporated, pursuant to Public Law 19-56, obtained real estate from the government of Guam (Lot No. 86-2 in the municipality of *Agaña*, containing an area of six thousand (6,000) square meters) to build its clubhouse to facilitate various programs and services for the *manåmko'* who call Guam their home; and

WHEREAS, the Government of Guam Association of Retired Persons, Incorporated, had served as the managing center of Guam's twelve (12) Senior Citizen Centers for many years until 2013, bringing much needed support to all of the senior population in coordinating various services such as meals, physical exercise, bingo, island-wide outings, *Manåmko'* Talent Showcases and Senior Citizens' Band to name a few; and

WHEREAS, the Government of Guam Association of Retired Persons, Incorporated, envisions an expansion of its facility with the construction of a *"Manåmko"* Legacy Center" and renovations to its existing building "A"; and

of the municipality of the capitol city of *Hagåtña* through the adoption of *Hagåtña*Municipal Planning Council Resolution No. 2015-01; and

WHEREAS, the Government of Guam Association of Retired Persons, Incorporated, has further received the endorsement through Chamorro Land Trust Commission Resolution No. 2009-03 of the request by the GGARP for the Guam Legislature to transfer to its organization a portion of Lot 86-R2, containing an area of 1.5 acres, municipality of *Agaña*, and to be consolidated with Lot 86-2, municipality of *Agaña*, subject to the survey for the said purposes of the multi-generational facility; and

WHEREAS, the Government of Guam Association of Retired Persons,
Incorporated, seeks the support of the Government of Guam for the planning and
construction of the "*Manåmko*' Legacy Center"; now therefore, be it
