1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***
2 ***MINA'TRENTAI TRES NA LIHESLATURNAN GUÅHAN:***

3 **WHEREAS**, Senior Grandmaster Frank Sanchez was born on April 21, 1948, in
4 the village of *Tamuning*; and is the son of Francisco C. and Rita R. Sanchez; and

5 **WHEREAS**, Senior Grandmaster Frank Sanchez holds an Honorary Doctorate
6 in Humanities degree from Great Plains Baptist College in South Dakota; and

1 **WHEREAS**, in 1971, Senior Grandmaster Frank Sanchez founded San-Jitsu,
2 Guam’s first internationally recognized martial arts style, which incorporates elements
3 of karate, judo, ju-jitsu, jing jow pai kung fu, wrestling, boxing and street fighting; and

4 **WHEREAS**, Senior Grandmaster Sanchez began studying martial arts at the age
5 of eleven (11), and worked his way up to earn black belts in karate, judo, ju-jitsu, and
6 jing jow pai kung fu; and

7 **WHEREAS**, Senior Grandmaster Frank Sanchez is currently featured in the
8 February/March 2016 issue of Black Belt Magazine, which is the world’s leading
9 martial arts magazine; and

10 **WHEREAS**, Senior Grandmaster Frank Sanchez is also a certified police trainer
11 with the Police Tactics Instructors of America; and

12 **WHEREAS**, on August 12, 1976, Senior Grandmaster Frank Sanchez was made
13 an Honorary Ambassador-at-Large for Guam by its then highest elected official, the late
14 Governor Ricardo J. Bordallo; and he was also a top island entertainer and recording
15 artist during the 1970s, singing under the stage name of “Frankie Sanchez”; and he was
16 featured on the “*Casamiento*” album with Johnny Sablan and other Chamorro artists;
17 and

18 **WHEREAS**, Grandmaster Frank Sanchez is also the Director and Founder of
19 “The World Head of Family Sokeship Council,” which is composed solely of 9th and
20 10th Grandmasters and their equivalents, and has over three hundred seventy-four (374)
21 members worldwide of every conceivable martial arts style and origin; and

22 **WHEREAS**, Grandmaster Frank Sanchez's martial art style of San-Jitsu has
23 received worldwide attention and is Guam’s first internationally-recognized martial arts
24 style; and

1 **WHEREAS**, Senior Grandmaster Frank Sanchez presently resides in
2 Jacksonville, Florida; and he travels around the world giving clinics and seminar
3 instruction; now therefore, be it


4 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Tres Na*

12 Honorable Edward J.B. Calvo, *I Maga'låhen Guåhan*.


