WHEREAS, I Mina'Trentai Tres Na Liheslaturan Guåhan desires to ensure the public's access to a timely public hearing within one hundred twenty (120) days of introduction on all bills, now therefore, be it

RESOLVED, that *I Mina'Trentai Tres Na Liheslaturan Guåhan* does hereby *amend* the Standing Rules - Part B, Rule VI, Section 6.01 (a)(1), by *adding* a new Subsection (a)(1)(i) to read: "(i) All bills introduced by a Member or a Committee *shall* be given a public hearing *no more than* one hundred twenty (120) days after the date of the bill's introduction. If the Committee to which the bill has been referred does not hold a public hearing within the one hundred twenty (120) day timeline, the Committee Chairperson *shall* give a reason in writing to the prime sponsor for not holding a public hearing. The prime sponsor may call and preside over a public hearing on such bill and report out such bill directly to the Committee on Rules."; and be it further

RESOLVED, that *I Mina'Trentai Tres Na Liheslaturan Guåhan* does hereby *amend* Standing Rules - Part B, Rule VI, Section 6.01 (a)(1), by *adding* a new Subsection (a)(1)(ii) to read: "(ii) Bills introduced prior to the adoption of Subsection (a)(1)(i) of this Section 6.01(a)(1) relative to the one hundred twenty (120) day rule, *shall* be considered eligible in calculating this timeline."; and be it further
