3 **WHEREAS, Maria Leon Guerrero, fondly known as “Kit,” has been an active**
4 **member in good standing of the Guam Memorial Hospital Volunteers Association**

1 (GMHVA) since October 2000, contributing to the success of the GMHVA with her
2 fifteen (15) years and more than nine thousand (9,000) hours of volunteer service; and

3 **WHEREAS**, Kit is blessed with three (3) children, all residing on Guam; as well
4 as eleven (11) grandchildren and three (3) great-grandchildren; and

5 **WHEREAS**, in April 2000, Maria retired from her career in the federal
6 government, where she had served as a Program Analyst. Six (6) months later, she began
7 her journey with the GMHVA after being recruited by the late Bennett San Agustin in
8 October 2000; and

9 **WHEREAS**, Maria served as the Association's Treasurer in the year 2000; and
10 she was instrumental in setting up a cash box/accounting for the Association's various
11 fundraising events, and she created the Thanksgiving Raffle ticket operations in the areas
12 of ticket sales accountability, and monitored its ticket sales and cash input. She and Judy
13 Salas (Assistant Operations) created the Thanksgiving Raffle ticket sales monitoring
14 system; and

15 **WHEREAS**, Maria ensured that the weekend schedules of the GMHVA
16 volunteers were covered, and she coordinated the cashier-volunteer duties with others.
17 She works every weekend and comes in to work every holiday, including Christmas and
18 New Year's, to provide service to the GMH patients, their families and hospital staff; and

19 **WHEREAS**, over the years, Maria has continued her volunteer work in various
20 positions that came her way, including supervision and/or assistance that was needed. She
21 has assisted in the daily operations of the GMH Gift Shop, and she volunteers her time
22 handling various duties, such as training the cashiers in the storefront sales operations,
23 coordinating their schedules, doing the accounting processes, counting the weekly cash,
24 auditing sales receipts, making cash box change, depositing weekly cash receipts,
25 coordinating the purchase orders for the store vendors, accepting sales merchandise,
26 calculating sales cost, pricing the merchandise, coordinating with the store volunteers in

1 ensuring placement of merchandise in the store, and assisting in the set-up of store
2 inventory processes; and

3 **WHEREAS**, Maria also helped to coordinate the scheduling of new volunteers to
4 work at the Gift Shop, and recruited some new members; and she had also held the
5 elected position of GMHVA Treasurer for five (5) years: 2002, 2003, 2004, 2005 and
6 2008; and because of her dedication and hard work she was voted as the GMHVA
7 “Volunteer of the Year” by her peers in 2003; and

8 **WHEREAS**, Maria’s experiences as a GMHVA member include her participation
9 in various fundraising projects, to include the Charity Ball, the Thanksgiving Raffle, the
10 Bake Sales, the White Elephant Sales, and many other volunteer activities; and

11 **WHEREAS**, in 2015, Maria served as the GMHVA Internal Auditor, and she is
12 currently active in various other community organizations; such as being the Treasurer
13 for nine (9) years with the Naval Marianas Federal Credit Union, as well as the
14 Chairperson for the Credit Committee. She has served as a Member of the Supervisory
15 Committee of Community First Federal Credit Union, and has also served as a member
16 of the *Toto* Christian Mothers and the *Toto* Latin Choir; and has done choir work at the
17 Friary, the Immaculate Heart of Mary Catholic Church in *Toto*, and the *Agaña* Cathedral-
18 Basilica; and she has served as a member of the Catholic Charismatic Group; and

19 **WHEREAS**, Maria is duly recognized as having met the requirements for
20 membership of this prestigious honor, and joins the ranks of the GMHVA “Lifetime
21 Members”, after completing twenty (20) years of actual volunteer service and eight
22 thousand (8,000) service hours; and


23 **WHEREAS**, Maria “Kit” Leon Guerrero is recognized among other GMHVA


7 **RESOLVED**, that *I Mina'Trentai Tres Na Liheslaturan Guåhan* does hereby, on
