2 Robeniol; Victoria Rebugio; and half-brother Landring Solamillos; and

3           **WHEREAS**, Maura, at the tender age of fifteen (15), took on the role of a  
4 mother figure to Teofilo and Victoria, her younger siblings, after the passing of their  
5 parents, while Benjamina and Landring were cared for by an uncle; and

6           **WHEREAS**, Maura remained single and devoted her life to providing for her  
7 family's needs by planting and harvesting rice and vegetables. Through her hard  
8 work, she eventually ran a small business as a rice vendor and would take her  
9 harvested vegetables to sell at the flea market; and

10           **WHEREAS**, Maura came to Guam on a Visitor's Visa to visit her sister,  
11 Victoria Rebugio, and was granted residential status. To this day, Maura lives with her  
12 sister Victoria who oversees her daily activities. Victoria is committed to ensuring that  
13 the health and welfare of her older sister is foremost, saying that it is now her time to  
14 care for Maura since Maura took care of Victoria when their parents passed away; and

15           **WHEREAS**, all her life, Maura was a homemaker, selflessly dedicating her life  
16 to ensuring that the needs of her family always came first; and

17           **WHEREAS**, Maura was once a participant of the *Astumbo* Senior Center,  
18 enjoying playing cards and bingo with her friends until her mobility declined; and

19           **WHEREAS**, Maura loves to drink water, her favorite soda is Sprite, and her  
20 favorite dishes are sinigang and chicken adobo, and she maintains her healthy eating  
21 habits by ensuring there are a variety of vegetables in her diet; and

22           **WHEREAS**, Maura enjoys watching television and even fulfills her spiritual  
23 obligation by attending Sunday mass through The Filipino Channel (TFC); and

24           **WHEREAS**, Maura has numerous nephews, nieces, relatives, and friends on  
25 Guam, the United States, and the Philippines; and

1           **WHEREAS**, Maura’s devotion and love of her family is a living testimony to  
2 reaching the age of one-hundred-three (103); now therefore, be it


3           **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Tres Na*

11 Edward J.B. Calvo, *I Maga’låhen Guåhan*.


