3 WHEREAS, it is the sense of *I Liheslaturan Guåhan* to recognize and honor 4 those distinguished citizens of this great island who have devoted themselves to faithfully serving the best interests of their community and the needs of Guam's
 residents; and

WHEREAS, attendant to such concern, and in full accord with its long-standing
traditions, *I Liheslaturan Guåhan* is proud to honor the graduating candidates of the
Spring 2016 Master of Public Administration (MPA) practicum course at the University
of Guam (UOG); and

7 WHEREAS, recognizing the growing presence of minors online due to the 8 increasing availability of electronic devices and accessibility to the Internet as 9 technology continues to advance, students of the Master of Public Administration 10 Program and the School of Business at the University of Guam established "Project 11 Foresight," an initiative to raise awareness on the dangers of sexting and cyberbullying 12 among Guam's youth; and

WHEREAS, building upon Guam Public Law 31-09—legislation spearheaded by Vice Speaker Benjamin J.F. Cruz to update and amend Guam's current criminal laws relative to sexting and cyberbullying—the students of Project Foresight launched a multi-pronged campaign in March of 2016, to incite public discourse on teenage sexting, encourage responsible and respectful texting among Guam's youth, and aid in the consideration of future policy recommendations relative to sexting; and

WHEREAS, to ensure successful community outreach, the students of Project Foresight collaborated with numerous key stakeholders, such as the Federal Bureau of Investigation (FBI), Guam resident agency; the Office of the United States Attorney of Guam and the Northern Marianas; the Office of the Attorney General of Guam; the Judiciary of Guam; the Guam Police Department; the Honorable Senators of the Thirtythird (33<sup>rd</sup>) Guam Legislature; and the LaniKate Task Force—comprised of representatives from the Healing Hearts Crisis Center, Child Protective Services, the

Guam Coalition of Sexual Abuse and Family Violence, and the Guam Department of
 Education (GDOE); and

3 WHEREAS, utilizing social media platforms to effectively communicate with 4 their target audiences, the students of Project Foresight also provided an online harbor 5 for victims of sexting to report or seek assistance for treatment; and

6 WHEREAS, at the conclusion of their practicum, the students of Project 7 Foresight successfully produced three (3) Public Service Announcements (PSA)— 8 targeted at audiences of varying age groups—that addressed issues such as bodily 9 autonomy, boundaries, cyberbullying, and the legal consequences of sexting. These 10 PSAs will serve as a supplement to the new Child Abuse and Sexual Harassment 11 Curriculum to be implemented at GDOE schools this year; and

WHEREAS, on May 5, 2016, the students presented the results of their
 campaign at the Project Foresight Stakeholder Briefing and PSA Launch, demonstrating
 a successful completion of their practicum course; and

WHEREAS, on behalf of the island, *I Liheslatura Guåhan* joins Dr. Robert Anacletus Underwood, President of the University of Guam; Dr. Annette Taijeron Santos, Dean of the University of Guam School of Business and Public Administration Program; and Dr. John J.
